

Information required under the Haryana School Education Rules, 2003.

It has come to my notice that the following information as required under the Haryana School Education Rules, 2003 have not been supplied by the private recognised schools within the state of Haryana:

- 1. Form IV Information regarding schools moveable and immoveable properties
- 2. Form VI minimum facilities to be provided and fees to be charged
- 3. Form VII Annual Inspection Format

All the private school authorities are bound to supply the information as required by the Director from time to time under Rule 30 (xxvi and xxvii) of Haryana School Education Rules, 2003 which are as under:-

Rule 30(xxvi)

"That the school furnishes such reports and information as may be required by the Director from time to time ad complies with such instructions of the appropriate authority or the Director as may be issued to ensure the continued fulfilment of the condition of recognition or the removal of deficiencies in the working of the school."

Rule 30 (xxvii):

"That all the schools shall maintain all records as per Rule 28. That all records of the school are open to inspection by any officer authorised by the Director or the appropriate authority at any time, and the school furnishes such information as may be necessary to enable the Government or the Director to discharge its or his obligations to the affiliated board, as the case may be."

You are directed to serve a copy of the notice attached to all the private recognised schools in the State of Haryana directing the schools to supply information under Forms IV, VI and VII of the Haryana School Education Rules, 2003.

The forms have been uploaded on departmental website. Each school has to make its own personal account on the website and enter the information required immediately. Last date for filing the information under various forms is 31st August 2011.


