





A copy of the appointment letter issued to the candidate may also be endorsed to the Commission."

As per Haryana State Education School Cadre (Group-B) Service Rules, 2012, the educational qualification for the post of Post Graduate Teachers for direct recruitment has been prescribed as under:-

- (i) Post Graduation with atleast 50% marks in relevant subject and B.Ed. from a recognized university (except PGT Computer Science); AND
- (ii) Matric with Hindi/Sanskrit or 10+2/B.A./M.A. with Hindi as one of the subject; AND
- (iii) Certificate of having qualified Haryana Teacher Eligibility Test (HTET)/ School Teachers Eligibility Test (STET).
- (iv) Consistent good academic record.


Further, the candidates having 4 year teaching experience were given relaxation as one time measure and they were also eligible for appointment to the post of Post Graduate Teacher as the said posts were advertised 1st time after the formulation of new Service Rules, 2012 provided that such person shall have to qualify the Haryana Teacher Eligibility Test (HTET) and B.Ed. by 1st April, 2015 (**now extended upto 1st April, 2022**) and if they fails to do so, their appointment shall stand terminated automatically without giving any further notice.

As per application form submitted by Sh. Leela Ram S/o Sh. Ram Kanwar, who was selected on the basis of 4 year teaching experience possessed from U.S. Sr. Sec. School, Pataudi, Gurugram and M.D. Sr. Sec. School, Mumtajpur, Gurugram from 18.03.2002 to 11.07.2005 and 01.04.2008 to 21.07.2012 respectively after getting the aforesaid one time relaxation.

The Department on the basis of the observation made by the Haryana Staff Selection Commission, Panchkula constituted Document Verification Committee (DVC) for verification of the academic certificates as well as documents of the schools which have issued the experience certificate. The report/observations of the committee in regard to the experience certificate issued by the school concerned in respect of Sh. Leela Ram S/o Sh. Ram Kanwar are as under:-

S.D. Sr. Sec. School, Mumtajpur, Gurugram	In the absence of availability of original record or corroborative evidence of school No. (ii) i.e. S.D. Sr. Sec. School, Mumtajpur, Gurugram, it can not be decided whether the teacher has actually worked in the said school or not in the relevant period. Hence, no decision can be taken regarding genuineness of the candidate.

As per observation made by the committee, the experience certificate is not to be considered genuine. Prima-facie, the case is made out for initiation of an appropriate action and to recommend to the Haryana Staff Selection Commission for cancellation of candidature in respect of Sh. Leela Ram S/o Sh. Ram Kanwar recommended by the HSSC, Panchkula for appointment as PGT in Geography. But before initiating any action, the show cause notice is hereby served as to why the recommendation for cancellation of the candidature in respect of Sh. Leela Ram S/o Sh. Ram Kanwar be not made to the appropriate authority. Reply, if any, you want to file in response to this notice may reach in the office of Director Secondary Education not later than 15 days from the date of the receipt of this notice. In case you fail to respond the notice within stipulated period, it shall be presumed that you have nothing to say/submit in this regard and decision will be taken ex-parte.
