In reference to this office memo No. 6/4-2013-HRL (4) dated 04.09.2015 on the subject cited above.

Vide above referred letter dated 04.09.2015, you were requested to initiate legal action by registering the criminal case against the school authorities of 9 schools namely Arya Sr. Sec. School, Nissing (Karnal), Asian Sr. Sec. School, Jaisinghpura (Karnal), BS Modern Sr. Sec. School, Gali No. 9, Shiv Colony (Karnal), Guru Hari Kishan Sr. Sec. School, Raitkhana (Karnal), SVM Sr. Sec. School, Rahara (Karnal), Arya Sr. Sec. Shiksha Sadan, Atta (Panipat), BRAM Janta Sr. Sec. School, Moti Nagar (Ambala City), National Sr. Sec. School, Babain (Kurukshetra) and PDM Sr. Sec. School, Durjanpur (Bhiwani) as the School Management concerned had issued multiple number of experience certificates in one subject knowing fully well that there are very less number of students in these subjects. On the basis of these manipulated teaching experiences, the candidates concerned have got their recommendation from Haryana School Teachers Selection Board and claimed appointments.


Accordingly, FIR were registered vide No. 17-18 dated 24.04.2016 u/s 420/467/468/471/120-B IPC at Police Station, State Vigilance Bureau, Distt. Rohtak and FIR No. 05 dated 04.05.2016 u/s 420/467/468/471/120-B IPC at Police Station, State Vigilance Bureau, Distt. Ambala against the Management and Candidates concerned, however, due to the reason that the Vigilance Department did not reach at any definite conclusion, the Govt. constituted District Level Committee under the Chairmanship of Sub-Divisional Magistrate of concerned District containing two members i.e. District Education Officer and Block Education Officer concerned vide order No. 6/12-

2016 PGT-I(4) dated 06.11.2017 and directed to submit progress report in this regard, so that, the matter can attain finality as soon as possible.

Accordingly, the District Level Committees so constituted, submitted its progress reports. As per progress reports, the DLC concerned reaches at a definite conclusion in regard to 1 school out of 9 i.e Arya Sr. Sec. Shiksha Sadan, Atta (Panipat) on the basis of available record, however, in regard to remaining 8 schools i.e. Arya Sr. Sec. School, Nissing (Karnal), Asian Sr. Sec. School, Jaisinghpura (Karnal), BS Modern Sr. Sec. School, Gali No. 9, Shiv Colony (Karnal), Guru Hari Kishan Sr. Sec. School, Raitkhana (Karnal), SVM Sr. Sec. School, Rahara (Karnal), BRAM Janta Sr. Sec. School, Moti Nagar (Ambala City), National Sr. Sec. School, Babain (Kurukshetra) and PDM Sr. Sec. School, Durjanpur (Bhiwani) due to non availability of record as the schools concerned have replied that the relevant record has been submitted in the State Vigilance Bureau concerned.

On the recommendation of the DLC, appointments were offered to eligible candidates and it was decided to withdraw the Vigilance Inquiry pending against Arya Sr. Sec. Shiksha Sadan, Atta (Panipat). Further, it has also been decided w.r.t. others to provide the record of schools concerned to the District Level Committees concerned, so that, the DLCs concerned can reached at any definite conclusion in the matter.

Therefore, you are hereby requested to withdraw the Vigilance Inquiry pending against Arya Sr. Sec. Shiksha Sadan, Atta (Panipat) and provide the record of schools mentioned above to the District Level Committees concerned constituted by the Government, so that, the DLCs can submit its final report in the matter and the matter can be finalized as soon as possible.
