Subject:- Guidance in respect of assuming full fledged charge of Principal of GSSS Khewra (Sonapat) .

Reference to vide No. E-7-17/1936 Dated 19.06.2017 on the subject cited above.

The following points in respect of this issue may be referred to as under:-

1. Sh. Chand Kishore Headmaster was transferred on administrative ground vide this Order No. 5/30-2015 HRG-II(2) dated 08.10.2015 from GSSS Khewra (Sonapat).

2. Thereafter he got a stay order from Hon'ble High Court in CWP No. 22040 of 2015. The stay order pertains to his transfer only from this school. This stay order does not imply that other activities of the school like upgradation, service matter of other staff members will not be processed.

3. This school got finally upgraded with the sanction of requisite posts of Principal and Lecturers latest on 16.01.2017. Upon full fledged upgradation of this school, the post of Principal has been created and the post of Headmaster has been abolished as a standard norm of upgradation. Subsequently Department issued promotion orders of Principals on 01.06.2017 and posted them in different schools. Smt. Darshana was also got posted on the vacant post of the Principal in GSSS Khewra (Sonapat).

4. It has been complained of that Sh. Chand Kishore Headmaster locked the room of Head of School and other staff establishment rooms with an intention to block the joining of Smt. Darshana by wrongly interpreting the Hon'ble High Court orders. In this way, Sh. Chand Kishore tried to take law in his own hands and he created hardle in the discharge of the duty by a public servant, namely, Smt. Darshana the Principal of the school. Not only this, he has shown gross insubordination by locking the school office, gate and other necessary facilities of the school to which the Principal of the school is validly entitled.

This case has been considered by the Directorate and it has been decided and you are accordingly guided that:-

(i) Smt. Darshana shall be allowed to assume full inchargehip of this school. This inchargehip shall include D.D.O Power, Supervision and control of the School Administration.

(ii) Sh. Chand Kishore shall remain in the school as Headmaster subordinate to the Principal, Smt. Darshana.

(iii) As the post of Headmaster got abolished automatically after the full and final upgradation of the school w.e.f. 16.01.2017, so Sh. Chand Kishore shall have to be moved to the other school for which the Department is planning to file Civil Miscellaneous Application before the Hon'ble High Court in CWP No. 22040 of 2015. Till the permission of Hon'ble High Court, Sh. Chand Kishore Headmaster will not be transferred from this school. However his salary can be arranged from some vacant post of a Headmaster in the District.

(iv) A detail report on the act and conduct of Sh. Chand Kishore Headmaster in the aftermath of the promotion and posting of Smt. Darshana may be sent to the Headquarter for further necessary action.
