Subject: Implementation of AEBAS (Aadhaar Enabled Biometric Attendance System) in 2nd & 3rd Phase

State Government had taken a decision on 03.03.2015 to implement Aadhaar Enabled Biometric Attendance System in the State of Haryana. The system has been implemented successfully in 1st phase which has become operational wef 2nd May-2015.

Phase 2: In the second phase all the Offices located at Chandigarh / Panchkula & at District HQrs shall be covered by 1st July 2015. The action plan for 2nd phase is attached alongwith as Annexure A.

Phase 3: In third phase the Offices located at Tehsil & Block Hqrs shall be covered by 1st August 2015.

Malpractice: Some instances were reported wherein Officers have got the device configured on their laptops in connivance with the technical nodal officer of their department. Instructions have been issued to all TNOs to immediately deactivate these devices & not to repeat the same in future.

A letter is proposed to be issued from Principal Secretary Coordination to all Administrative Secretaries/HODs detailing timelines for various activities in Phase-2.

AEBAS rollout timelines for Phase 2 and Phase 3 as indicated above, may kindly be got approved from Chief Secretary, Haryana please.
