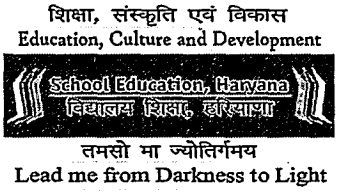

Subject: Regarding HTET/B.Ed. Qualified information

Reference to the notice dated 14.03.2018 regarding subject cited above (copy attached).

After scrutiny of qualification data as filled by the teachers in their personal profiles on MIS Portal, it is observed that many PGTs have not uploaded their complete/correct information about their qualification on MIS Portal. Especially information about HTET/STET or B.Ed. in relevant subject is not available for many PGTs on MIS Portal.

Before initiating any action against the defaulters, department has decided to give last opportunity to fill requisite complete information in their profiles on MIS Portal.

Therefore, all the teachers are directed to update their complete/accurate qualification details (i.e. B.Ed., HTET etc. by mentioning subject and passing year) in their MIS Profile immediately, scanned copies of certificate should also upload in the profile.

Heads of school / profile approving authorities are also directed to approve these updation immediately after verifying the record. District Education Officers are requested to ensure that all the necessary updation should be done before 20th May, 2018.

(Regarding HTET/B.Ed. Qualified information)


Reference to following clause in Haryana State Education School Cadre (Group B) Service Rules, 2012 and Mewat District School Education (Group B) Service Rules, 2012, vide which all PGTs appointed under said rules have to qualified their Haryana Teachers Eligibility Test (HTET) in relevant subject upto 1st April, 2018.

“Note: (i) In case of direct recruitment the teachers working in privately managed Government aided, recognized and Government schools, are exempted to acquire qualifications of passing HTET as described in column 3 if they have worked as a teacher for a minimum period of four years on the date of enforcement of these rules.

*However, the said exemption is as a onetime measure and the said category of teachers on their appointment shall have to qualify HTET by not later than 1st April 2015 (**later extended upto 1st April 2018**), otherwise their appointment shall stand terminated automatically without giving any further notice.”*

Therefore, all the PGTs are directed to update their complete/accurate qualification details (i.e. B.Ed., HTET etc. by mentioning subject and passing year) in their MIS Profile immediately, scanned copies of certificate should also upload in the profile.

Heads of school / profile approving authorities are also directed to approve these updation immediately after verifying the record. District Education Officers are requested to ensure that all the necessary updation should be done before March 31st, 2018.
