In partial modification of instructions issued by General Administration Department letter No. 22/10/2013-1GSIII dated 6th April, 2018, Para 3 is hereby withdrawn and substituted as under;
2(a) The 10% reservation for ESP in Group D posts will be compartmentalized horizontal reservation between Un-reserved/General, Scheduled Castes and Backward Classes categories as under:

Sr. No.	Category	Quantum of reservation	Roster points
(a)	ESP(SC)	2%	30&80
(b)	ESP(BC'A')	2%	32&74
(c)	ESP(BC'B')	1%	63
(d)	ESP(Un-reserved/General)	5%	13,31,51,71 & 91

(b) In case, there remains shortfall in any of the compartmentalized groups mentioned above, the same can be filled in the same recruitment from the other compartmentalized group and vice versa i.e. in case the vacancy remains in ESP (SC), same can be filled from ESP (Un-reserved/General) or any other group as per availability and merit of the eligible candidates (s), so that the 10% quota for ESP can be filled.

3. Rest of instructions issued vide General Administration Department letter No. 22/10/2013-1GSIII dated 06.04.2018 shall continue as such.
4. This may please be brought to the notice of all concerned for strict compliance in letter and spirit.
