The Haryana AAROHI (Educationally Backward Block) EBB Model Schools Society is pleased to offer you engagement as PGT on contract basis on the following terms and conditions:

1. **Term of Appointment:** Your contract will be initially for one year which is extendable on fulfillment of certain conditions on year-to-year basis.

Provided that the concerned Principal of school shall issue a certificate that the contract appointee had rendered 'satisfactory service'.

2. **Nature of Appointment:** Your services will be purely on temporary basis and the engagement is liable to be terminated in case the performance/conduct is not found satisfactory. You will not have any claim for continuation of service beyond the contract period. You will not work and hold any other post or office of profit in any Government, semi-Government and Private establishments while working in the society. No right to hold the post gets conferred upon you on account of your continuance on the post without any extension by the competent authority and you can be relieved of your duties at any time thereafter, without giving any prior notice.


