Subject: **Scheme for payment of pension through e-pension System.**

I am directed to invite your attention to Finance Department letter No. 14/81/2012-5FA dated 10.09.2012, No. 2/32/2012-1 Pension dated 30.11.2012, 20.11.2013, 03.12.2013, 01.07.14 and 08.12.2017 vide which State Government has prescribed the detailed procedure in respect of pensioners/family pensioners who are covered under e-pension system.

A number of representations have been received from the pensioners/family pensioners to review the decision regarding change of month for submission of life certificate & updation of PPO and change of bank A/c.


After due consideration, the State Government has decided to amend the instructions issued vide letter no. 14/81/2012-5FA dated 10.09.2012 and No. 2/32/2012-1 Pension dated 01.07.14 in respect of e-pension system in the following manner:-

So PPO holder should ensure that PPO is updated in the month of <b>November every year.</b></p> <p>Further updations of PPO can be got done from any Treasury/Sub Treasury of the State.</p> <p>Apart from this each pensioner has to appear before any TO/ATO of the State for the pension of <b>November paid in December</b> every year and furnish requisite certificates e.g. Life Certificate etc.</p>
			<b>3 (v)</b>	The month referred in the point as March paid in April may be read as <b>November paid in December.</b>
<b>2.</b>	Letter No. 14/81/2012-5FA dated <b>10.09.2012</b>	Change of bank A/c.	<b>2 (ii)</b>	<p>The following para shall be added in the end of <b>point no. 2(ii)</b>-</p> <p>"That if any pensioner give the application for the change of his/her bank account in the pension system from one branch to another branch of bank, then <b>NOC from the concerned bank branch</b> from where the pensioner is holding bank account may be submitted to the TO/ATO for change of account in pension system.</p>
