No. 6/2/2018-1Cabinet.— In exercise of the powers conferred by clauses (2) and (3) of article 166 of the Constitution of India, I, Kaptan Singh Solanki, Governor of Haryana, hereby make the following rules to further amend the Business of the Haryana Government (Allocation) Rules, 1974, namely:-

- 1. These rules may be called the Business of the Haryana Government (Allocation) Amendment Rules, 2018.
- 2. In the Business of the Haryana Government (Allocation) Rules, 1974, in the Schedule, for the heading, brackets and signs "ENVIRONMENT DEPARTMENT (Through the Secretary to Government, Haryana, Environment Department)", the heading, brackets and signs "ENVIRONMENT AND CLIMATE CHANGE DEPARTMENT (Through the Secretary to Government, Haryana, Environment and Climate Change Department)" shall be substituted.
