I am directed to refer to State Government Instruction No. 34/01/2004-4GSI, dated 20.06.2018 on the subject cited above.

The matter has been further considered by the State Government and it has been decided as below:

Relates to Admn. Br

1. The Cabinet has empowered the Committee chaired by Chief Secretary to decide the classes of officials that can be re-employed. After approval of the Committee, the matter does not need to be taken again to CMM.
2. When seeking applications for re-employment, the Administrative Department should prescribe upper age limit for re-employment as 63 years so that officials can serve for at least two years i.e. till the age of 65 years.
3. The Haryana Civil Services (Government Employees' Conduct) Rules, 2016 & Haryana Civil Services (Punishment & Appeal) Rules, 2016 should be made applicable on such contractual appointments and a clause to this effect should be prescribed in their appointment letters.
4. Emoluments to be paid to retired persons should be as prescribed in chapter XI of Haryana Civil Services (Pay) Rules, 2016.

These instructions may be brought to the notice of all concerned.
