Subject:- Raising the upper age limit for entry into Government Service.

Sir,

I am directed to refer to Haryana Government letter of even No. dated 26-8-2014 and 5-12-2017 on the subject noted above vide which it was decided to raise the maximum age of entry into Government service from 40 to 42 years. All the departments were requested to amend their service rules accordingly. Council of Ministers in its meeting held on 30.05.2018 has decided that all departments shall incorporate the provisions relating to raising the upper age limit for entry into the Government Service in their Service Rules, at their own level without obtaining the approval of CMM, General Administration, Finance Department and Haryana Public Service Commission/ Haryana Staff Selection Commission.

2- You are requested to kindly implement the decision of the Council of Ministers at the earliest.

These instructions should be brought to the notice of all concerned for immediate compliance.
