- 1. In pursuance of the order dated 02.02.2011 passed by the Hon'ble Punjab and Haryana High Court, Chandigarh in CWP No. 11686 of 2004 titled as Haryana State Adhyapak Sangh (Govt. Aided Private Schools) versus State of Haryana and others, the State Government has decided to allow Assured Career Progression to the teaching & non-teaching employees of Privately Managed Govt. Aided Schools in the State of Haryana in terms of the Notification No. G.S.R./Const./Article 309/08 dated 30.12.2008 w.e.f. 01.01.2006 titled as Haryana Civil Services (Assured Career Progression) Rules, 2008 subject to outcome of the SLP being filed in the above cited matter and Review Petition No. D8247 of 2012 filed by the Higher Education Department Haryana, Panchkula against the order dated 19.09.2011 passed by the Hon'ble Supreme Court of India in SLP (Civil) No. 24467 of 2011.
- 2. The orders of implementation be done with the condition that if the SLP/Review Petition is decided in favour of the State, the amount/benefit, given to the concerned beneficiaries i.e. the petitioners shall be recovered from their salaries.
- 3. Assured Career Progression may be granted to those employees whose qualification and nature of work are similar to that of Govt. employees working in field offices.
- 4. This issues with the concurrence of Finance Department, Haryana conveyed vide U.O. No 78/38/11-3FD-II-4413, dated 18.02.2013.
