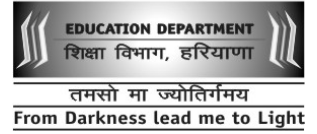

- The appointment will be subject to the final decision / outcome of various Civil Writ Petitions in the Hon'ble High Court relating to the said appointments.**
- He/She is appointed purely on temporary and provisional basis.

3. That this appointment is against temporary post and its confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
4. The candidate shall have to take an oath of allegiance to the Constitution of India.
