Subject: Mechanism for implementation of the provisions of Rule 134-A of Haryana School Education Rules, 2003 amended in 2013.

In continuation of this office letter No.KW 3/10-2010 RTE (1) dated 31.03.2015, the mechanism devised/schedule of admission for classes 2nd to 8th under Rule 134-A of the Haryana Education Rules, 2003, amended in 2013, vide letter under reference is hereby issued. However, the reimbursement to private unaided recognized schools for the expenditure incurred in providing free education under the aforesaid rule shall be subject to the final outcome of the Review petition proposed to be filed by the State in compliance of the liberty granted by Hon'ble Supreme Court in SLPs(CC) No.12843-45 of 2015 filed against the order dated 1.4.2015 passed by the Hon'ble High Court in CWP No.4925 of 2014 and connected matters and subject to the obligations of private schools under second proviso of section 12 (2) of RTE Act, 2009.

In pursuance of the schedule issued vide letter dated 31.03.2015, the list of applicants had been prepared by the Block Level Committees but the draw of lots could not be held. Now, the schedule here onward shall be as under:-

- (i) First draw of lots at Block Level – **14th August, 2015** and it can continue to the next day, if necessary.
- (ii) Admission on the basis of the first draw of lots – **19-20 August, 2015.**
- (iii) 2nd draw of lots for remaining seats - **24th August, 2015.**
- (iv) Admission on the basis of 2nd draw of lots – **25th August, 2015.**
- (v) 3rd draw of lots for remaining seats, if left – **27th August, 2015.**
- (vi) Admission on the basis of 3rd draw of lots – **28th August, 2015.**
- (vii) If seats remain vacant even after 3rd round, schools will submit their list to District Level Committees before **04th September, 2015.**

The remaining conditions will be the same as already issued vide letter dated 31.03.2015.

Grievances Redressal Mechanism:

Schools failing to comply with the provisions of Rule 134-A of Haryana School Education Rules 2003 shall be subjected to withdrawal of recognition by the Department under the relevant rules on the recommendations of the District Level Committee. Any aggrieved person can submit his/her complaint either before District Level Committees or Block Level Committee. It must be ensured that the above instructions are complied with in letter and spirit.
