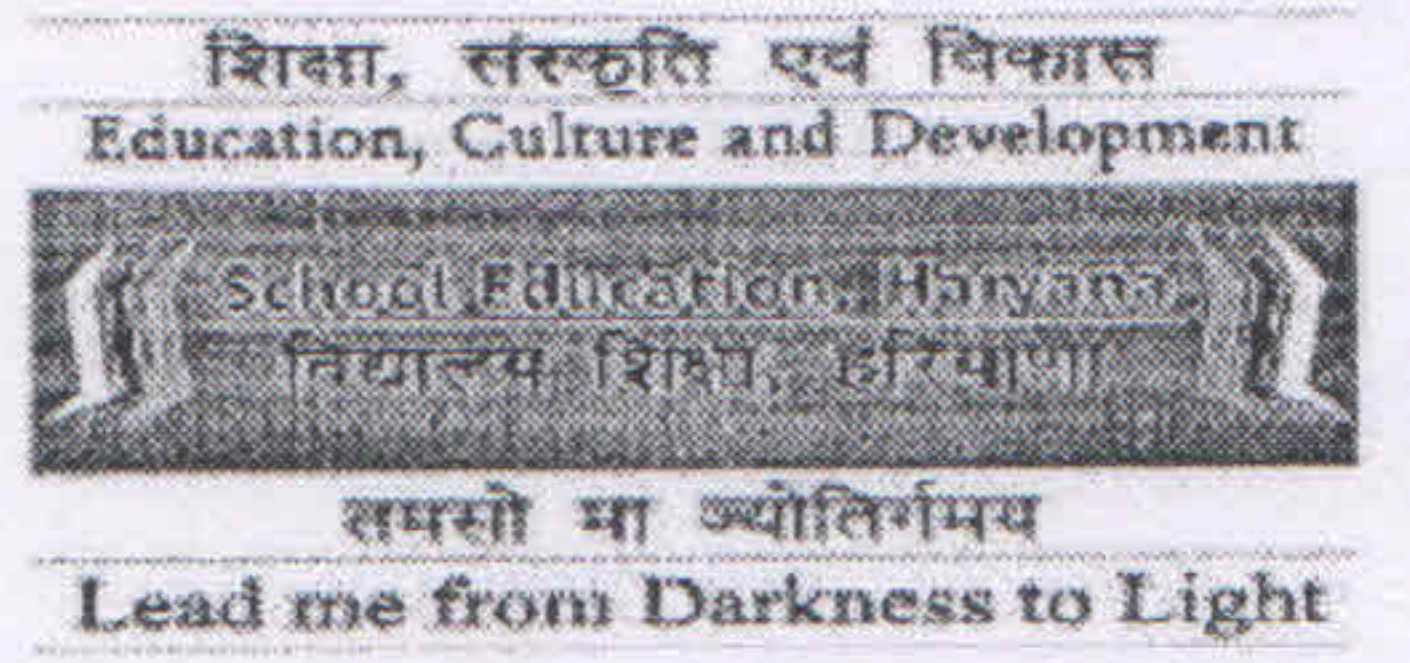

Sub: Regarding pending salary of Computer Faculty deployed through the private Service Providers in Govt. High/Sr. Sec. Schools.

This has reference to this office memo no. 3/11- 2013 CEC (1) dated 13.07.2015 regarding salary of Computer Faculty for the period from 01.06.2014 to 22.03.2015 i.e. prior to the date of termination of contract.

In this regard, number of clarifications are being sought from the concerned SIMs as mentioned in the letter of 13.07.2015. The matter regarding following issues are being clarified as under for information of all concerned Heads/Principals.

- I. The payment shall be made strictly as per attendance record of Computer Faculty available in school.
- II. Monthly salary of Computer Faculty is same as per the agreement with the Service Providers i.e. 12000 per month.
- III. The salary of summer and winter vacation is admissible as per the provisions of agreement with the Service Providers of Computer Faculties. However, the salary is not admissible to those Computer Faculties who were on strike during this period.
- IV. One day casual leave per month of the duty performed shall be permissible. The deduction for absence from duty for days more than admissible casual leave shall be worked out on the basis of total no. of days in that particular month.
- V. All the payment shall be made through Cheque in the name of beneficiary i.e. Computer Faculty.

Concerned Principal/ Head of the Schools will be responsible for any type of lapse in disbursement of the salary of the Computer Faculty.

The District Education Officer are directed to monitor the proper disbursal of pending salary to the Computer Faculty.
