



**Subject:- Counting of Daily Wages service towards pension.**

I am directed to invite your attention on the instructions bearing No. 4/53/2009-2Pension(FD) dated **17.3.2010** issued by this department on the subject noted above.

2. It has come to the notice of the State Government that the Hon'ble High Court has struck down the provisions of rule **3.17A(f)(i)** of CSR Vol-II in case of **Sh. Joginder Singh vs. State of Haryana decided by the Hon'ble Punjab & Haryana High Court vide its judgment dated 12.12.1997 in 1998(1) RSJ 671**. Further this order/ judgment attained finality as State Government has not filed any appeal against this judgment.

So now after careful consideration it has been decided to count the **full period instead of half period** of service of such person paid from contingency towards pension by amending **sub clause (i) of clause (f) of Rule 3.17-A** of the Civil Service Rules Vol-II to that extent. The above amendment takes effect from the date of judgment dated **12.12.1997 in 1998(1) RSJ 671 Joginder Singh Vs. State of Haryana and others.**

In view of above, you are requested to take action in all the cases of your department accordingly.

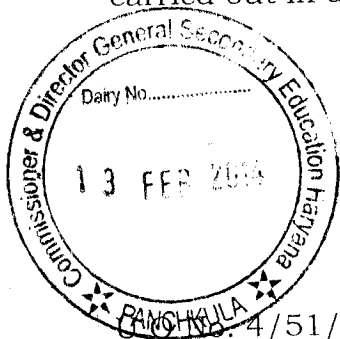
