Subject:- Grant-in-Aid/Financial Assistance to the Gurukuls/Sanskrit Pathshalas in the State of Haryana for the year 2011-12.

Kindly refer to the subject cited above.

Sanction of the Governor of Haryana is hereby accorded to the issuance of administrative approval for the inclusion of the scheme cited as above in the schedule of new expenditure for the year 2011-12 and incurring of an expenditure on Non-Plan and Non-Recurring basis of Rs. 40,50,000/-(Rs.Forty Lacs and Fifty Thousand Only) as Grant-in-Aid/Financial Assistance to the Gurukuls Sanskrit Pathshalas in the state of Haryana under various units of appropriation subject to the following conditions:-

- 1- The expenditure will be made as per Budget Provision for the financial year 2011-12.
- 2- Under no circumstances the total amount drawn during the financial year shall exceed the amount indicated in this sanction order.
- 3- The Grants to the Gurukuls/Sanskrit Pathshala will be made out of the funds specially provided by the State Government under the policy of "Grant-in-Aid to the Gurukuls/Sanskrit Pathshalas" for assisting Gurukuls/Sanskrit Pathshalas imparting instruction in Sanskrit.
- 4- The Grant-in-Aid would be provided to the Gurukuls/Sanskrit Pathshalas which are in existence for 10 years or more on the basis of student strength.
- 5- The Grant-in-Aid/Financial Assistance would be given lump-sum on the basis of student criteria as under:-
