No. 8/5/2014-4IB-II dated 26<sup>th</sup> February, 2014

In exercise of the powers conferred by Section 85 of Haryana Registration and Regulation of Societies Act, 2012 (Act 1 of 2012), as amended vide Haryana Registration and Regulation of Societies (Amendment) Act, 2013, the Government of Haryana is pleased to order that:

1. Societies registered under the Haryana Registration and Regulation of Societies Act, 2012, (as amended up to date) and comprising of His Excellency, the Governor of Haryana, the Chief Minister/a Cabinet Minister of Haryana, Chief Secretary or any of the Administrative Secretaries or Divisional Commissioners or Deputy Commissioners in the State of Haryana, as their President/Chairmen and Government Officers as Office bearers /members in their ex-officio capacity, are hereby exempted from the application of Section 33 and Section 39 of the said Act, containing provisions for elections of Governing Body.
2. The Societies registered with the Khadi and Village Industries Commission, Government of India, and the Haryana Khadi and Village Industries Board, operating in the State of Haryana, are exempted from the application of provisions contained in sub section (2) of Section 46 and Section 90 of the Haryana Registration and Regulation of Societies Act, 2012.

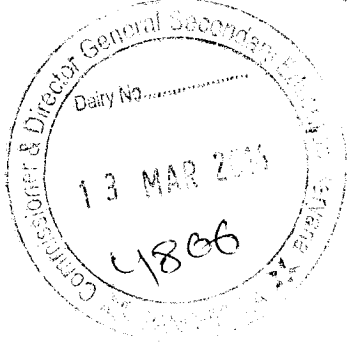
