

Subject: Schedule of New Expenditure (SNE) for the year 2016-17 (Plan) for the Re-imburement of fees under Rule 134-A students in admitted in private schools for the year 2015-16 under the head, "2202- General Education-01 Elementary Education-800-Other Expenditure-(State Plan Schemes-Part 1)-(93) Right to Education Act-51NA—34)Other Charges-(Plan)".

Sanction and administrative approval of the Governor of Haryana is hereby accorded to incur an amount of Rs.6,82,58,400/-(Rs. Six crore, eighty two lac, fifty eight thousand and four hundred only) for the Re-imburement of school fees under Rule 134-A for EWS/BPL students admitted in private schools for the year 2015-16 @ Rs.200/- per student of classes II to V and Rs.300/- per student of classes VI to VIII of the Rural Area (out side Municipal Limits) private schools and @ Rs.300/- per student of classes II to V and Rs.400/- per student of classes VI to VIII of the Urban Areas (with in Municipal Limits) private schools as per budgetary provisions for the year 2016-17 and the district wise number of students and their amounts details are given below:--


