INVITATION FOR BIDS

This invitation of bids is for providing UPS Batteries, on-site installation & commissioning with buy back option for Haryana EDUSAT Network:

1. Bidders are advised to study the Tender Document carefully. Submission of Tender shall be deemed to have been done after careful study and examination of the Tender Document with full understanding of its implications.
2. Sealed Bids should be submitted to The Commissioner & Director General School Education, Haryana, 30 Bays Building, IIIrd Floor, Sector-17B, Chandigarh 160017 not later than the last date of submission .
3. All bids must be accompanied by an Earnest Money of Rs.10 Lac in the form of Bank Draft in favour of “**Commissioner & Director General School Education, Haryana,**” payable at Chandigarh.
4. This Tender document is not transferable.

SCOPE OF WORK

Haryana EDUSAT Network consists of 10,500 terminals of Satellite Interactive Terminal and Receive Only Terminal (DTH/ROT) in the state of Haryana. The network is owned by Education Department, Govt. of Haryana. All above terminals are provided with Uninterrupted Power Supply (UPS). The department is looking for replacement of these UPS batteries across the state of Haryana at various sites of educational institutions and its offices. The batteries are required on-site installation & commissioning with buy back options.

Technical Specifications of UPS Battery:

- *100 AH/12 Volt, SMF type (Sealed Maintenance Free).*
- *Quantity required per site*
03 Batteries in Satellite Interactive Terminals (SIT) Site.
02 Batteries in Receive Only Terminals (ROT) Site.
- *Compatible with 1 KVA UPS having 04 hours back-up on full application load.*

INSTRUCTIONS TO BIDDERS

PROCEDURE FOR SUBMISSION OF BIDS:

It is proposed to have a Two-Cover System *for* this tender.

- a) Technical Bid in one cover.
 - b) Commercial bid in one separate cover.
-
- a. The Technical Bid should be filled in original and should be sealed in a separate cover. The Technical bid should be superscribed as "Technical Bid-Envelope A; Tender No **3/10-2009 NPE (1)** and put in the cover along with EMD. The Bidder should sign all pages of the Pre-qualification cum Technical bid.
 - b. The commercial Bid in the prescribed format should be filled in original in a separate cover. The Commercial Bid should be superscribed as "Commercial Bid- Envelope B; Tender No **3/10-2009 NPE (1)**".

The Bidder should sign all pages of the commercial Bid.

Pre-qualification cum Technical Bids will be opened on the prescribed date (**i.e. on 11 March, 2010**) and time (**i.e. 3:30 P.M.**) and checked *for* submission of EMD and other applicable documents specified.

The covers thus prepared should also indicate clearly the name and address of the Bidder to enable the Bid to be returned unopened in case it is received "Late".

The bids received late and declared late by the Tender Evaluation Committee, after the last date and time *for* receipt of bids prescribed in the tender document shall be rejected and/or returned unopened to the Bidder.

TENDER EVALUATION

1. The Technical Bid will be opened and checked *for* eligibility criteria and Financial Bids of only those bidders who qualify the Eligibility Criteria will be processed further.
2. The successful bidder(s) shall be issued a Letter of Intent by the Commissioner & Director General School Education, Haryana, detailing the name of UPS locations where batteries are to be replaced. Pursuant to this, the successful bidder(s) shall execute the task of batteries replacement with C&DGSE, Haryana Chandigarh, within 60 days of Letter of Intent, failing which his EMD shall stand forfeited. The LOI of such Bidders will be then offered to other bidders.

Cost of Tender document

1. The Bidder shall bear all costs associated with the preparation and submission of its Bid, including cost of presentation for the purposes of clarification of the bid, if so desired by the C&DGSE, Haryana, Chandigarh will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the Tendering process
2. The Bidder is expected to carefully examine all instructions, forms, terms and specifications in the Tender Document. Failure to furnish all information required in the Tender Document or submission of a bid not substantially responsive to the Tender Document in every respect will be at the Bidder's risk and may result in the rejection of the bid.

Clarification regarding Tender Document

A prospective Bidder requiring any clarification of the Tender Document may contact the C&DGSE, Haryana Chandigarh personally. The C&DGSE, Haryana Chandigarh will try to respond to the query there and then, however submission of request for clarification will not entitle the Bidder for any extension of time in submission of the Tender Document.

Amendments in the Tender Document

1. At any time up to the last date for receipt of bids, the **C&DGSE, Haryana Chandigarh** may, for any reason, whether at his own initiative or in response to a clarification requested by a prospective Bidder, modify the Tender Document by an amendment.
2. The amendment will be notified on website of Directorate <http://www.schooleducationharyana.gov.in> and will be binding on them.
3. In order to afford prospective Bidder/Bidders reasonable time or otherwise for any other reason, in which to take the amendment into account in preparing their bids, the **C&DGSE, Haryana Chandigarh** at his discretion, extend the last date for the receipt of Bids.

Language of Bids

1. The Bids prepared by the Bidder and all correspondence and documents relating to the bids exchanged by the Bidder and the C&DGSE, Haryana Chandigarh, shall be written in the English language, provided that any printed literature furnished by the Bidder may be written in another language so long as accompanied by an English translation in which case, for purposes of interpretation of the bid, the English translation shall govern.

Financial Bid - consisting of the following:

- 1) The Bidder shall indicate the firm rate as per Financial Offer Format for indicated Tasks in the scope of work.

TERMS AND CONDITIONS OF THE TENDER

1. BIDDER'S QUALIFICATION:

The Bidder should be an established "Manufacturer/stockiest/distributor of UPS SMF Batteries "incorporated as a Private/ Public Limited Company or a Registered Firm in India and fulfilling the following preconditions and must also submit documentary evidence in support of fulfilling these conditions while submitting the technical bid:

- 1. The bidder should have been registered and functioning in the field of SMF batteries for at least three years.**
- 2. The annual turnover of the bidder should be minimum Rs. 100 Crores (Rupees One Hundred Crore) for the last three financial years or a manufacturing unit that has produced similar ISI marked battery units and the manufacturing unit is ISO certified will also be eligible to participate with requisite EMD of Rs. 10.00 Lac.**
- 3. That the bidder should have experience of supplying, installation of UPS SMF batteries to a large project particularly in Government, Public Sector Undertakings.**
- 4. ISO 9001-2000 certified bidders will be preferred.**

Penalty Clause:

1. Penalty clause: Delay of installation @ Rs. 1,000/- per day.

EARNEST MONEY & SECURITY:

The Bidder must deposit Earnest money, along with tender document, Rs 10 Lac in the form of Bank Draft in favour of "*The Commissioner & Director General-School Education, Haryana Chandigarh*", payable at Chandigarh.

GUARANTEE:

The Guarantee period shall be 3 years from the date of installation. In case, any fault reported in the batteries after installation, replacement shall have to give within 4 week failing which, penalty of Rs. 500/- per day shall be imposed and deducted from the security amount for the default period.

BILLING:

Billing will be made in the name of concerned Directorate of Education as per work order.

SALE TAX/VAT/CST:

The Department will not supply any C Form and full amount of Sales Tax/ VAT/CST as applicable shall be charged by the supplier.

TERMINATION FOR DEFAULT:

1. The C&DGSE, Haryana Chandigarh may, without prejudice, to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the contract in whole or in part. if:
 - a. The qualified Bidder fails to deliver any or all of the obligations within the time period (s) specified in the contract, or any extension thereof granted by the C&DGSE, Haryana Chandigarh.
 - b. The qualified Bidder fails to perform any of the obligation(s) under the contract
 - c. The qualified Bidder becomes, bankrupt or otherwise insolvent, provided that such termination will not prejudice or effect any right of action or remedy which has accrued thereafter to the C&DGSE, Haryana Chandigarh.

CONFIDENTIALITY:

The Bidder (s) and their personnel shall not, either during the term or after expiration of this contract, disclose any proprietary or confidential information relating to the services, contract or the C&DGSE, Haryana's business or operations without the prior written consent of the Directorate of School Education, Haryana.

FORCE MAJEURE:

1. Notwithstanding the provisions of the tender, the Bidder shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, its delay in performance are other failure to perform its obligations under the contract is the result of an event of Force Majeure.
2. For purposes of this Clause, 'Force Majeure' means an event beyond the control of the Bidder and not involving the Bidder and not involving the Bidders fault or negligence and not foreseeable. Such events may include, but are not restricted to, acts of the Directorate of School Education, Haryana either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
3. If a Force Majeure situation arises, the qualified Bidder shall promptly notify the Directorate of School Education, Haryana in writing of such conditions and the cause thereof. Unless otherwise directed by the Directorate of School Education, Haryana in writing, the Bidder shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. The Directorate of School Education, Haryana may terminate this contract, by giving a written notice.

GOVERNING LANGUAGE:

The contract shall be written in the language of the bid, as specified by the **C&DGSE, Haryana Chandigarh**, in the Instructions to Bidders clause. All correspondence and other documents pertaining to the contract, which are exchanged by the parties, shall be written in that same language.

OTHER CONDITIONS:

1. All disputes, differences, claims and demands arising under or pursuant to or touching the contract shall be referred to the sole arbitrator i.e. Financial Commissioner & Principal Secretary to Govt. Haryana, Education and Languages

Department, Chandigarh. The award of the sole arbitrator shall be final and binding on both the parties under the provisions of the arbitration and conciliation Act, 1996 or by statutory modification reenactment thereof for the time being in force. Such arbitration shall be held at Chandigarh.

2. In all matters and disputes arising there under the appropriate Courts at Chandigarh alone shall have jurisdiction to entertain and try them.
3. The Directorate of School Education, Haryana reserves the right to accept or reject any/all tenders without assigning any reason.
