Concededly, he was placed at No. 1 in the waiting list. It is not disputed either that three of the candidates, who were selected by respondent No.3, never chose to join. And that being so, the petitioner being at number 1 in the waiting list, ought to have been offered an appointment. The stand set out on behalf of respondent No.3 is; that name of the petitioner could not be recommended by the Commission, as the concerned department, i.e. Director, Secondary Education, Haryana (respondent No.2), never communicated or informed the Commission that three of the candidates have not joined. Ex facie, the lapse, if any, lies with the respondents. Even otherwise, learned senior counsel for the petitioner submits that the matter in issue is squarely covered by an order and judgment dated, March 4, 2013, rendered by this Court in LPA No. 1767 of 2012 (Ritu d/o Sh. Nafe Singh Vs. State of Haryana and others) [Annexure P-9].
