

As per report of the District Education Officers, it has been found that 719 guest faculty in all streams were engaged contrary to the instructions.



In compliance of the Hon'ble Court direction passed in Civil Writ Petition No. 4587 of 2011 dated 05.08.2011, an opportunity of personal hearing is also given to you on 31-7-2012 to put forward your defence in support of your claim before the departmental committee headed by Joint Director Secondary Education. The committee submitted its report to the undersigned and observed that your appointment as Science Master guest faculty is against the Govt. Instructions.

After going through the reply filed by you and report of the committee, it has been found that your initial engagement was not in accordance with the departmental instructions because you have not possessed requisite qualification to your credit as guest faculty. Consequently, your service is hereby terminated with immediate effect.
