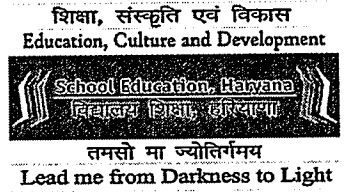

Hence you are again requested to kindly ensure the availability of internet connectivity having minimum 2mbps speed in all DIETs & Schools
