





It is a gated colony having pleasant green landscape. A large community centre having convenient Shopping, Multipurpose Hall, Gym room etc. is provided in the complex.

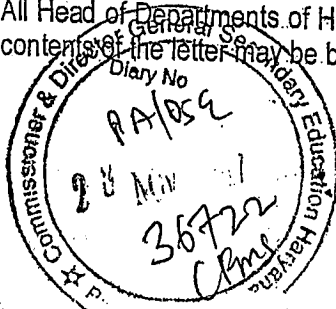
