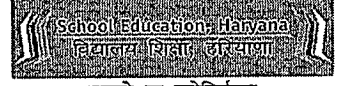

In the recent times, many incidents have taken place in the State whereby the safety of the students, teachers and schools has been seen to be comprised. These incidents bring a bad name to the schooling system. To prevent recurrence of such incidents like Ryan International School, Gurgaon and others, we need to put in place a standard operating procedure/guidelines/regularizations for compliance of one and all stakeholders. As safety concerns require immediate response, so, a structure which is proximate to the schools need to be created. So the District level committees or school level safety committees are required to be provided for. To frame detailed, relevant and effective guidelines, a committee of the officers of School Education Department is need of the hour.

Accordingly, a committee of the following officers is hereby constituted to frame guidelines for the safety of the students and teachers of the schools :-

1. Additional Director (Admn.), Office of Director Elementary Education Haryana.
2. Additional Director (Admn.), Office of Director Secondary Education Haryana.
3. District Education Officer, Panchkula
4. District Attorney, Office of Director Secondary Education Haryana
5. Deputy Director (Utkarsh).
6. Assistant Director (Academic Cell).
7. Representatives of Private Schools.

This committee shall propose the guidelines as expeditiously as possible but not beyond two days.
