Sub: Disbursement of salary of Computer Faculty & Lab Assistants engaged in the month of September 2015.

This has reference to this office Memo of even no. dated 08.09.2015 and further clarifications issued vide memo of even no. dated 19.09.2015. The Principals/Head of schools were authorized to engage qualified persons for the position of Computer faculty and Lab Assistants, on short term basis as an interim arrangement, for imparting Computer Education for the current academic session upto 31.03.2016.

Accordingly, based on the information provided by the DEOs in respect of the Joining Reports of Computer Faculty and Lab Assistants, estimated amount is being transferred to the account of DPC's for salary of Computer Faculty @ Rs. 10,000/- per month & Lab Assistants @ Rs. 6,000/- for further disbursement to the concerned schools for the period from 09.09.2015 to 31.12.2015. The details of amount being transferred District-wise are enclosed as Annexure 'A'. The list of Computer Faculty and Lab Assistants for whom the salary is being released is enclosed District-wise as Annexure 'B' and Annexure 'C' respectively.

In pursuance to the instructions/clarifications issued vide aforesaid Memo dated 19.09.2015, the salary is payable only to the following Computer Faculty and Lab Assistants.

1. The Computer Faculty who had worked on contract basis through the Service Providers (namely M/s Bhupindra Society, Transline Technologies Ltd. and Shriram New Horizons Ltd.) prior to the cancellation of contract with the Service Providers on 22.03.2015.
2. Lab Assistants who had worked on contract basis through the Service Providers (i.e. CORE Education & Technologies Ltd and HCL Infosystems Ltd).

The concerned schools are required to disburse the salary of Computer Faculty and Lab Assistants as per their actual attendance for the period from 09.09.2015 to 31.12.2015 and deposit the surplus/excess amount in the account of concerned DPC.

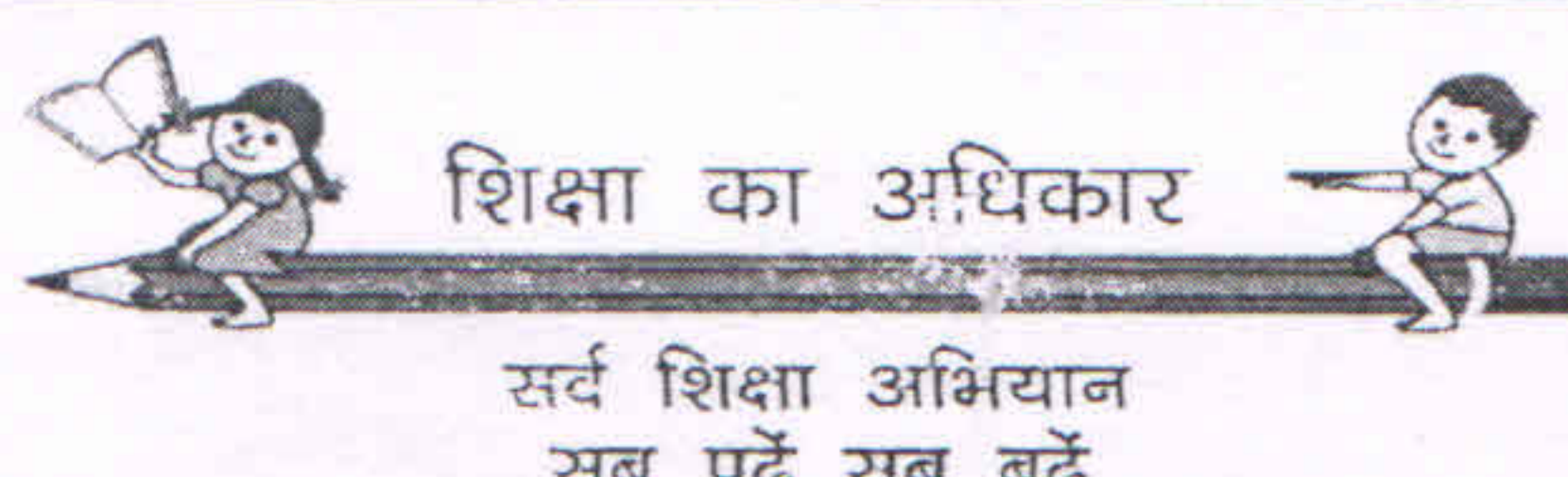
