

Subject: Clarification on duty joining issues.

1. Through representations of many PGTs it has been noticed that some heads of school are denying the joining of duties to the teachers on the grounds like, the teachers who were transferred on 01.04.2016 vide order no 2/587-2015-HRL-I(1) were put under the condition that:
 - i) 'In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy'
 - ii) And, 'The official will be relieved immediately and in any case within 7 days failing which he/she will be liable for disciplinary action'
2. Further, some of these teachers applied for adjustment to the directorate. In the meanwhile, they kept on working on their present stations.
3. Now, the directorate has issued posting orders in respect of newly promotee PGTs as the MIS data reflects vacancy on the station. As a consequence, the new teacher has reached the station wherefrom the earlier PGT was ordered to be transferred vide order dated 01.04.2016 but the earlier one might be waiting for adjustment so far.
4. In such a scenario, the heads of schools are:
 - a. either not letting the promotee PGT to join citing the reasons that the adjustment request in respect of earlier PGT is pending.
 - b. or, in case of relieving, the next head of school is not allowing them to join citing reasons of conditions of '7 days period' or 'rural-urban services' of para 1(i) or 1 (ii) above.
5. In this context, it is made clear that the 'rural-urban service' condition put in the orders dated 01.04.2016 was an inadvertent error so the same may be ignored.
6. Further, the '7 days period' condition has also become infructuous because the department has not acceded to the request of adjustment of the former PGT. Rather, the department has posted a new PGT, thereby, re-affirmed that the adjustment will not be granted to the former PGT.

In view of above discussion, all heads of school are directed that they should ignore both these conditions and allow the movement of the teachers as per the posting/transfer orders.
