Subject: Introduction of Applied Skills-Coverage of additional Govt. Sr. Sec. Schools from 2017-18 academic session under CSS-VSHSE.

Dear DEOs,

As you are aware, School Education Department/HSSPP has been implementing Centrally Sponsored Scheme- Vocationalisation of Secondary and Higher Secondary Education in 990 Govt. Sr. Sec. Schools with 14 skills (2 skills in each School). The intake capacity during the current academic session has reached 93,000. Haryana has been quoted as a role model for the successful implementation of the scheme. All this has been possible with the close collaboration association/participation of various stakeholders which interalia include vocational trainers, field functionaries like schools Heads, DPCs, DEOs.

There is a plan to cover more Govt. Sr. Sec. Schools from the ensuing academic session commencing from April 2017. As per GOI guidelines and also various other parameters, the strength in class 9th, the aptitude of the students for a particular skill to be opted, manpower requirement as reflected in the skill gap report of the districts, infrastructure available, proximity of the industry etc have to be kept in view while recommending introduction of a particular skill in the school.

As per scheme of studies, these skills have been included in the basket of optional subjects. Since school identified for the introduction of skills has to opt for two skills with 25 students each, in case other optional subjects already available in the schools and also regular teachers are available, Principal has to ensure that at least 50 students are available for opting these skills commencing from class 9th. In other words the school opting for these schools should have atleast 80 or above students on rolls in class IX. At the same time, possibility to introduce single skill in schools with lessor

strength and 3rd/4th skill in the schools where two skills already stand introduced but the student strength in class 9th justify 3rd/4th skill is also being explored .

Parishad is also in touch with NSDC New Delhi and PSSCIVE Bhopal to ascertain the new courses, particularly in the service sector for which the course content alongwith defined job is being developed. These will be made available by them shortly. Meanwhile, you are requested to bring this plan of action to the notice of school Principals which have not been covered under the scheme as yet and also schools where 3rd/4th skill can be introduced. Please identify those schools who fulfil the above parameters. The identification may be done by collecting data in the enclosed formats.

I hope you will pay personal attention, share the communication with the school Principals and ensure that the data as required is collected by giving wide publicity and the schools so shortlisted be shared in the enclosed format with the Parishad at email nsqfharyana@gmail.com by 26.12.2016 in any case.
