Memo No. 8/34-2008 PS (2) Dated Panchkula, the 19.05.2017

Subject: Extension of one year to private schools for fulfilling the norms as prescribed in the Haryana School Education Rules, 2003 amended in 2007 and 2009.

Kindly refer to the subject cited above.

It is stated that the District Level Committees (for short DLCs) constituted under the Chairmanship of concerned Deputy Commissioner was authorised to finalize the cases of permanent recognition under the provisions of Haryana School Education (Amended) Rules, 2007 amended in 2009 which were notified on 21.02.2009 and subsequently notified in 2013 and 2014.

It is further stated that lists of the private schools, the cases of permanent recognition of which have not been finalized by the District Level Committees as yet, were demanded from all the Distt. Education Officers/ Distt. Elementary Education Officers to ascertain the actual number of such schools. On the basis of the lists supplied by the DEOs/DEEOs, it has been found that the cases of permanent recognition of 933 private schools have been rejected by the DLCs and the cases of permanent recognition of 1159 private schools are still pending before the DLCs. These schools have admitted students for the current academic session also.

Keeping in view the interest of the students admitted in these schools, the Government has decided:-

- i) to grant provisional recognition to the aforesaid 1159 private schools (the list attached) for one year i.e. till 31.03.2018;
- to grant extension to such private schools (out of 933 schools) who have filed appeals against the order of rejection of their permanent recognition by DLCs and if the appeals are still pending before the competent authority. However, such schools shall submit the documentary proof regarding filing of appeal. So, as regards the rejected schools eligible for provisional recognition list shall be issued separately subsequently.

It has also been decided that no school will be allowed to run as unrecognized school from the next academic session i.e. 2018-19 starting from 01.04.2018 and any act contrary to provisions of the Rules will invite appropriate action under the Rules.
