But the school office is indulging in procrastination thereby causing avoidable harassment to the teacher. Not only this, the important teaching hours/energy of a teacher is being wasted on unnecessary work for which she has to travel upto Headquarter to get the work done. The school office has not shown even a modicum of interest in resolving this issue. Rather, it has chosen to pursue the path which generates unnecessary pains to the academic staff.

Therefore, you are directed to either resolve the issues highlighted by the teacher in her representation or appear personally before the DSE, Panchkula for explaining the reasons of delay or refusal to entertain the representation of the teacher.

Subject: To fix the pay as per 7th pay commission and draw the salary the period of 16.08.2016 to 31.08.2016

Respected Sir,


With reference to the subject cited above I, Punam Gupta, have been selected and joined as PGT Home Science at DSE Panchkula on 16/8/2016 F.N. vide DSE Panchkula order no. 13/6-2016 HRL-I (4)/Home Science dated 11/08/2016.

On 30.8.2016 I was adjusted to DEO office Ambala vide DSE order no 2/163-2016 PGT-II (3) dated 30.8.2016 and then I was temporarily adjusted to GGSSS Naraingarh (Ambala) -31 vide DEO Ambala order no E-2/16/1223 dated 31.8.2016.

I participated in 2nd transfer drive vide DSE memo no 2/140-2016-PGT-II(1) dated 14.02.2016 in which my name was in optional category at Sr. no 1. The candidates whose name was in optional category have choice to fill their preferences or not. In case these participants choose not to fill their preferences completely then it will be presumed that they do not want their transfer from their present stations accordingly they will be retained at their present stations. As my name was in optional list, I decided not to fill the preferences. But I was still transferred to GGSSS Ambala city (Baldev nagar)-69 vide order no. 2/140-2016-PGT-II dated 21.12.2016. I gave representation to The Additional Director through email and personally on 22.12.2016 and in response to the representation my transfer was cancelled vide order no. 2/140-2016-PGT-II(1) dated 23.12.2016 (showing my name at sr. no. 15) and I was retained in the GGSSS Naraingarh -31 which was also shown at my MIS profile. Now I am working in GGSSS Naraingarh (Ambala) -31 as PGT Home Science.

Principal GGSSS Naraingarh denied to draw my salary of above said period i.e. 16 Aug to 31 Aug 2016 and to prepare my service book and fixing my pay according to 7th pay commission despite the orders issued by D.S.E. Haryana bearing order no. 2/140-2016 PGT-II (1) dated 19.09.2016, BEO Naraingarh order no. 659 dated 7/10/2016, DEO Ambala order no E-2/17/9733 dated 3/2/17 and DEO order no. E-2/17/9783A dated 14/3/17. He also denied to receive the letter issued by Additional Director Sh. Virender Seharavat dated 2/3/2017. Principal GGSSS Naraingarh has written my name in the last by Red Pen in teacher's attendance register, he repeatedly uses the words that you are temporarily adjusted and not employee of this school, this is not your office although I have been allotted this station by DSE in 2nd transfer drive. He also denied to allot the Home Science as optional subject to the students of 11th class. So please look in the matter for necessary remedy. I shall be highly thankful to you.
