Applications for recruitment of PGTs in Kisan Adarsh Vidyalas in Haryana.

Online applications are invited for filling up of the under mentioned categories of posts under Modal School Scheme in Kisan Adarsh Vidyalas on contractual basis initially for a period of one year and further extendable on yearly basis subject to satisfactory performance. **These posts are purely contractual in nature. The online application form can be filled up at the website <http://recruitment-portal.in> up to 5.00 P.M. on 20/08/2014 thereafter, website link will be disabled.** The candidates are strongly advised to apply online well in time without waiting for the last date of submission of online application. The candidate will bring the printed copy of the online application form along-with necessary certificates at the time of verification of document, No offline application form or copy of downloaded application form will be accepted by the office. Qualification/eligibility conditions, age and certificates will be determined with regard to last date fixed for submission of online application form. The details of posts as under:-

No. 1: Post Graduate Teachers (PGTs) (91 Posts)

Qualifications common to all categories of PGTs :

- (i) The subject in which Post Graduation is done should be one of the subjects in Graduation; and
- (ii) B.Ed./M.Phil with 50% marks from recognized university.
- (iii) Matriculation with Hindi/Sanskrit or 10+2/B.A./M.A. with Hindi as one of the subject; and
- (iv) Certificate of having qualified State Teacher's Eligibility Test (STET)/ Haryana Teacher's Eligibility Test (HTET)/National Eligibility Test (NET).; and
- (v) Proficiency in teaching in English and Hindi medium; and
- (vi) Consistent good academic record; and
- (vii) Conversant in IT skills and effective use of new technologies as tools for learning.
- (viii) In case of PGTs, in the subjects of English, Physics, Chemistry, Mathematics and Commerce, the candidates who have qualified National Eligibility Test (NET), condition of B.Ed./M.Phil. will not be applicable.
- (ix) **Age:** 21 to 40 as on 20-08-2014.
- (x) Essential qualification (EQ) is given with each post.

1 (a) : 16 posts of PGT English
M.A. English with at least 55% marks from recognized university.

1 (b): 19 posts of PGT Physics
M.Sc. Physics/ Applied Physics/ Nuclear Physics/Electronics Physics with at least 55% marks from recognised university.

1 (c): 19 posts of PGT Chemistry
M.Sc. Chemistry or Bio- Chemistry with atleast 55% marks from recognized university.

- 1 (d): 19 posts of PGT Mathematics**
M.A./M.Sc. Mathematics/ Applied Mathematics with atleast 55% marks from recognised university.
- 1 (e): 18 posts of PGT Commerce**
M.Com. with Accounting/Cost accounting/Financial accounting as a major subject of study with at least 55% marks from recognized university. Holders of degree of M.Com. in Applied/ Business Economics shall not be eligible.
- No. 2: Pay Scale:** The incumbent appointed will be paid consolidated contractual amount on the basis of currently applicable basic salary on the said posts. In addition, the DA, House Rent and fixed medical allowance, as applicable from time to time on the Government pattern will also be paid. **At current rates, the total approximate entry level emoluments will be Rs. 16890/- for the post of PGTs.**
- No. 3: Application Fee:** Application fees (non-refundable) amounting to Rs.500/-+Rs.20 (Bank charges) for General and other category candidates and Rs.250/-+Rs.20 (Bank charges) for Female/SC/PH candidates of Haryana state will be payable through challan, generated after online filling of application. Candidates belonging to other reserved categories (SC/BC/ESM/PHC candidates of Haryana State) must ensure that they have valid caste certificate issued by the competent authority. In case, at the time of verification of documents, it is found that certificates are not valid, their candidature will be rejected.
- No. 4: Consistent Good Academic Record** means that out of the lower qualifications i.e. Graduation/10+2/Matric etc., other than the requisite minimum qualification, one must secure atleast 55 % marks in one lower examination and 50% in the two lower examinations. If there are only two lower examinations, then one must have secured atleast 55 % marks in one lower exam and 50% in another.
- No. 5:** Professional Training Diploma or Certificate awarded by any State, Board or University other than Haryana Education Department will be recognized only if this Degree or Diploma or Certificate has been recognized by the Haryana Government.
- No. 6:** A Diploma/degree course in teacher education recognised by the National Council for Teacher Education (NCTE) only shall be considered. However, in case of Diploma in Education (Special Education) and B.Ed. (Special Education), a course recognized by the Rehabilitation Council of India (RCI) only shall be considered.
- No. 7: 33% posts in each category shall be reserved for women and this reservation shall be horizontal.**
- No. 8:** Candidates having qualified HTET/STET conducted by Haryana Board of School Education, Bhiwani for this category of teachers only will be eligible.
