Sub: Correction in some transfer orders dated 6.8.2016.

It has been seen that the transfer orders in respect of some PGTs, particularly the newly promoted ones, generated during the latest general transfer drive carried out on 6.8.2016, contain slight discrepancy in the sense that those promoted PGTs who had already joined their new place of posting given vide order dated 17.6.2016 have been shown in the orders dated 6.8.2016 as if they are still working in their previous school before promotion. Whereas it is a fact that some of these teachers had already joined the new stations upon promotions so such discrepancy needs to be explained.

For an illustration a case of one teacher is enclosed herewith. In this case Smt. Namita (091584) is shown to be transferred from Government middle Habatpur to Government Senior Secondary School Basai, whereas she had joined school prior 6.8.2016 at GGHS Pipaltha. Therefore, in place of GMS Habatpur GGHS Pipaltha should have been mentioned in the Transfer order dated 6.8.2016. Such minor discrepancies crept in due to non-updation of MIS profile at the latest joined station.

Accordingly, it has been decided that all concerned may read the latest joined school prior to order dated 6.8.2016 as the school of transfer for the purposes of orders dated 6.8.2016.

At the same time, the Heads of earlier institutions may also digitally relieve such employees on MIS Portal, so that MIS profile may also become updated for future uses. For relieving on MIS Portal, a teacher is not needed to approach the heads of earlier institutions. After relieving on MIS Portal from the earlier school these teachers may be joined and this information may be updated on MIS Portal by the head of the present institution.

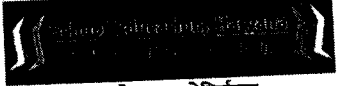
