Subject: Schedule for admission in class 1st under RTE Act 2009.

Please refer to the subject cited above.

Further, It is stated that in compliance of the order dated 01.04.2015 passed in CWP No. 4925 of 2014 and connected matters, a mechanism for admission in classes IX to XII and II to VIII under Rule 134-A was issued by the department vide letter dated 30.04.2015 and 12.08.2015 respectively.

Whereas, the Hon'ble High Court while disposing of CWP No.4925 of 2014 and connected matters vide its common order dated 01.04.2015 has directed that reservation and admission to class 1st and pre-school education wherever provided, the private un-aided schools is to be made as per the provisions of RTE Act 2009 and not in accordance with rule 134-A.

Whereas rule 7 of the RTE Rules 2011 deals with admission of children belonging to weaker section and disadvantaged groups. This Rule has been amended vide the Haryana Right of Children to Free and Compulsory Education (Amendment) Rules 2015 and sub-rule (7) has been added in this rule, which is reproduced here as under:-

"(7) Notwithstanding anything contrary contained in sub-rules (1) to (6) of this rule, all admissions of the children belonging to weaker section and disadvantaged groups under clause (c) of Sub-section (1) of Section 12 of the Act shall be made only in Class-I, if such children are unable to get admission in the schools referred to in sub-clauses (i) and (ii) of clause (n) of Section 2 of the Act due to non-availability of seats, then their parents or guardians may apply to get admission in the schools referred to in sub-clauses (iii) and (iv) of clause (n) of Section 2 of the Act against the twenty-five per cent seats reserved for them. Admission to these seats shall be made as per instructions issued by Director, Elementary Education Department from time to time for this purpose. The reimbursement of the expenditure incurred by the schools referred to in sub-clause (iii) and (iv) of clause (n) of Section 2 of the Act shall be made by the Department of Elementary Education, Haryana for such children under provisions of Sub-section (2) of Section 12 of the Act."

As per the aforesaid amended rule, the admission in 1st class under RTE Act upto 25% is to be given preferably in Govt. schools and Govt. aided private schools. In the event, there is no seat available in these schools then the parents of children can apply for admission in a school belonging to specified category and in an un-aided private recognized school.

You are, therefore, requested to ensure the admission to the children belonging to weaker section and disadvantaged groups in class 1st and pre-school education wherever provided, under RTE Act 2009 and rules framed thereunder.
