Sub:- **Reconducting test for admissition in Private School under rule 134-A of the Haryana School Education 2003,**

Kindly refere to the subject noted about.

As you are aware a test is to be held on **3<sup>rd</sup> July, 2016** at block level for admission in Private Schools under Rule 134-A of the Haryana School Education Rules, 2003 to fill up the remaining vacant seats. The test is to be held by a committee headed by the Additional Deputy Commissioner as constituted vide order no.8/13-2016PS-1 dated 25-04-2016. The question paper of the test in both languages i.e. in **Hindi and English** will be supplied by the Director S.C.E.R.T. Haryana, Gurgaon for the class 9<sup>th</sup> and question paper for the class 10<sup>th</sup> & 12<sup>th</sup> will be supplied by Director Secondary Education, Haryana, Panchkula whereas all other aragements are to be made by the concerned District Education Officer in the District under the guidance and supervision of the Additional Deputy Commissioner.

Following arrangements are to be made by the District Education Officers in their Districts:-

1. Identification of sufficient number of examination centres at the block level keeping in view the number of applicants in the block.
2. Suitable furniture for the students in the examination halls, drinking water, and cleanliness of bath rooms, etc.
3. Appointment of sufficient staff for invigilation in the examination halls at the Block level.
4. Supply of answer sheets for the students in the examination.
5. Appointment of staff for table meeting/evaluation of answer sheets at the district level.
6. Compilation of result at the district level.
7. Proper police arrangements at the examination halls to be ensured by the ADC in consultation with the Deputy Commissioner and Superintendent of police.
8. The lists of examination centres, staff for invigilation and evaluation to be sent to the Directorate within two days.

Schedule for reconducting test for admission in classes 9<sup>th</sup>, 10<sup>th</sup> and 12<sup>th</sup> under Rule 134-A of Haryana School Education Board 2003 as amended 2013.

1. Number of remaining vacant seats (classwise) under Rule 134-A will be declared by all Private Schools by 30<sup>th</sup> June, 2016.
2. Test for the remaining students coming from Private School to be held on 3<sup>rd</sup> July, 2016 at 9:00 AM to 12:00 Noon at the Block level. Details can be had from offices of DEOs' and BEOs'.
3. Draw of lots at Block level will be held on 07<sup>th</sup> July, 2016. Admission on the basis of draw of lots will be from 8<sup>th</sup> to 15<sup>th</sup> July, 2016.
4. Second draw of lots, for remaining seats, if any, will be held on 18<sup>th</sup> July, 2016. Admission on the basis of second draw of lots will be from 19<sup>th</sup> to 22<sup>th</sup> July, 2016
5. If seats remain vacant even after second round, concerned Schools will submit their lists to District Level Committees by 25<sup>th</sup> July, 2016.

Note: - The merit for admission in class 11<sup>th</sup> will be determined on the basis of the marks obtained by them in the Board Examination of 10<sup>th</sup> class.
