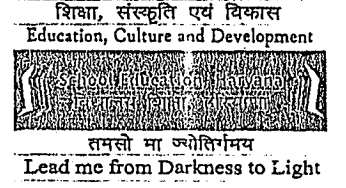

Dated Panchkula, the 28.09.2018**

Subject: - Delegation of DD Powers of Block Education Offices.

Kindly refer to the subject cited above.

Consequent upon transfer of Block Education Officers to the post of Deputy District Education Officer vide order no. 4/26-2018 HRG-I(2) dated 07.09.2018, most of the posts of Block Education Offices in the State of Haryana has become vacant which is adversely affecting the working of these offices.

In order to deal with such situation, all District Education Officers are hereby delegated powers for authorizing senior most principals of the block to exercise the DD Powers of respective block where the post of Block Education Officer is vacant, till regular incumbent is posted against these vacancies by way of Promotion/Transfer/Adjustment/Deputation, on the following terms & conditions:-

1. Only senior most Principal of the block will be granted DD Power of Block Education Office.
2. There shall be no disciplinary action pending against the officer to whom DD Power is to be granted.
3. That District Education Officers will intimate this office after issuance of DD Powers to deserving officers in writing and non compliance of this instruction will be attract disciplinary action.
4. That District Education Officers will ensure that employee ID and Station Codes are precisely mention on the orders.
5. That respective District Education Officer will be held responsible for any lapse in delegation of powers and disciplinary action will be initiated against them.
6. Those District Education officers will forward the case to this office if any dispute arises or any clarification is required by specifically mentioning the fact of the case.
7. That District Education Officers will face litigations, if any, arising due to delegation of DD Powers by their office.



8. That District Education Officers will sought clarification from Directorate if any contradiction is found in present instruction and the orders passed by the Directorate previously by precisely mentioning the facts of the case,
9. That these instructions will remain in operation until regular incumbent are posted by way adjusted/transferred/ promoted/deputation on these vacant posts.

It is once again reiterated that present proposed mechanism is temporary measure to deal with present circumstances and will become null & void automatically once the department issue promotion list of Block Education Officers.
