With refrence to your DO NO. 49-40/2015/NCTE/N&S/47992, Dated 27.12.2016 received in this office on 02.02.2017 on the subject cited above.

In this regard, it is intimated that there are 25 Govt., 325 Private Self-Financig and 14 Private Self financing Minority D.Ed (Deploma in Education) institutes (total 364 intitutes) with total intake capacity of 20600 in Haryana State.

Since 26th June, 2012 Haryana Education Department has sent the requisition for the appointment of only 9870 Primary teachers which is much lower than the total number of candidates passed out from D.Ed (Deploma in Education) institutes in the State till now.

Taking in view of the above facts, the state has also conveyed its decision (i.e. not to recommend any fresh opening/recognition or increase in intake of any D.Ed institutes in Haryana State for the year 2013-14, 2014-15, 2015-16, 2016-17 and 2017-18) vide following letters:-

2. 17/10-DIET dated 16.01.2015 to Prof. Santosh Panda, Chairperson, NCTE, Delhi.
3. AD-4/2015/244 dated 12.02.2015 to Regisional Director NRC, Jaipur.
4. 17/10-DIET (TE) dated 03.04.215 to Regisional Director NRC, Jaipur.
5. Sh. Jag Lal Singh, Member Secretary, NCTE.

In Continuation of the above decision, the State Govt. has decided to reiterate their early decision, in view of available capacity i.e not to recommend any fresh opening recognition or increase in intake of any D.Ed institute (Private Self-Financing and Private Self- Financing Minority Institutions) in Haryana State for the year 2017-18 and 2018-19 also. So, you are again requested that fresh applications may not be entertained in this regard.
