**Subject: Regarding granting relaxation in type test for granting increments to the Clerks, whose pay will be fixed by granting deemed date of appointment on the basis of CWP No. 20057 of 2013 Satyapal vs. State of Haryana and other connected 22 Writ Petitioners .**

Kindly refer to the subject cited above.

That vide order dated 30-09-2015 passed by Hon'ble High Court in a bunch of 23 Writ Petitions, the petitioners were allowed to open GPF Accounts as per old pension scheme. Further, the benefit of seniority w.e.f. 12-04-1990 alongwith notional pay fixation was also allowed to the petitioners. The matter regarding relaxation of passing type test was refer to Chief Secretary to Govt. Haryana. The Chief Secretary vide UO No. 3/2/2016-3GSII dated 08.03.2016 has conveyed that no relaxation has been granted by the General Administrative Department in this matter as there is no provision in Government instructions for granting such type of relaxation.

It is therefore, requested that necessary action in this regard may be taken accordingly.
