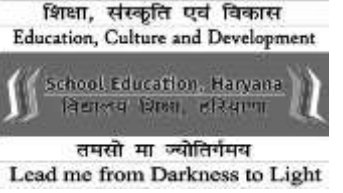

Therefore, these teachers are hereby transferred on the administrative grounds. A disciplinary action under Rule-8 is also been initiated separately against them and their approving authorities.
