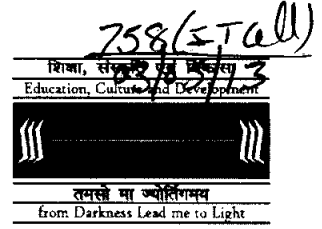


In compliance of order dated 4-5-2012 passed in CWP No. 1792/2010, Sh. Lal Chand, Clerk, O/o BEO Sahabad (Kurukshetra) now GSSS Bhakli (2446) is hereby given Show Cause Notice as under:-

Whereas, Sh. Lal Chand, Clerk, O/o BEO Sahabad (Kurukshetra) now GSSS Bhakli (2446) was charge sheeted under Rule -7 of Haryana Civil Services (Punishment and Appeal) Rules 1987 vide order No. 5/55-94 ME (4) dated 23-4-1999 on the following charges:-

1. श्री लाल चन्द लिपिक दिनांक 12.3.1997 से 11.12.1998 तक बिना किसी अवकाश/सूचना के विद्यालय से अनुपस्थित रहा।

He submitted his reply dated 17-5-1999 and denied the charges. Finding his reply unsatisfactory, Shri M.L. Kalra, District Primary Education Officer, Kurukshetra was appointed as an Inquiry Officer vide order No. 5/55-94 ME (4) dated 10.04.2000 to inquire into the charges levelled against him. He submitted his Enquiry report on dated 16.08.2000. The Inquiry Officer stated the charges of willful absence proved against him. A Copy of enquiry report has already been sent to Sh. Lal Chand Clerk.

After going through the inquiry report, I fully agree with the conclusion arrived at by the Inquiry Officer and held that all the charges levelled against him stand fully proved. As such, I feel that he is not fit to be retained in Govt. Service. I am, therefore, provisionally, of the opinion that a penalty of dismissal from service be imposed against him. Before taking such action, I would like to offer him an opportunity of showing cause as to why the proposed action should not be taken against him. Any representation, if any, he would like to make in this connection, will be duly considered by the undersigned. Such a representation, if any, should be submitted in writing within 15 days from the receipt of this memorandum by him failing which it will be presumed that he has nothing to say in this regard and action will be taken accordingly.



* The managing committee shall abide by the provisions of Haryana School Education Rules 2003 (amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provisions of the rules.
