Whereas Smt. Indu Chaudhary, Lect. Economics at GSSS Muklan (Hisar) has filed a CWP No. 22932 of 2011 in the Hon'ble Punjab & Haryana High Court, claimed therein back wages for the period from 19.12.2004 to 10.2.2005 for which she could not joined on the post due to fault of the department may be released to her. This writ petition was disposed of by the Hon'ble Court on 12.12.2011 with the following directions:-

**"After hearing the learned counsel for the petitioner, I deem it appropriate to dispose of the instant writ petition with a direction to the respondents to decide the representation (Annexure P-7) made by the petitioner as expeditiously as possible. Order accordingly"**

That in compliance of the aforesaid direction of the Hon'ble Court the claim of the petitioner was considered and it has been observed that petitioner was selected as Lecturer in Economics and posted as such at G.G.S.S.S. Dhani Phogat (Bhiwani) vide your office order No. 6/32-2004-E-IV (4) dated 10.12.2004 but she could not join there for want of vacancy in the institution. Thereafter, on the representation of the petitioner regarding post of Lecturer in GGSSS Dhani Phogat she was adjusted at G.G.S.S.S., Jhojhu Kalan (Bhiwani) vide order No. 6/32-2004-E-IV (4) dated 16.12.2004 but this time again she could not join on the post for non availability of the vacancy in the school. In the meantime a model code of conduct was enforced due to assembly election in the State of Haryana. Keeping in view of the above her posting order was kept pending. However, subsequently she was posted at GGSSS Behal (Bhiwani) on 11.02.2005.

Consequent upon the judgment dated 07.02.2005 in CWP No. 1636 of 2005, she was adjusted at GGSSS Behal (Bhiwani) vide order No 6/32-2004-E-IV (4) dated 10.02.2005 issued by Financial Commissioner and Principal Secretary to Government of Haryana, Education Department in view of the decision dated 21.01.2005 passed in CWP No. 833 of 2005. There is no

intentional lapse on part of the department, to delay the joining of petitioner. She could not join on the post due to non availability of post and subsequently due to imposition of code of conduct in the State of Haryana. Seniority was fixed as per recommendation sent by the Haryana Public Service Commission. However, she deserves annual increment w.e.f. her joining and notional benefit of pay fixation be granted to her accordingly.

In view of the position explained above, I pass an order accordingly.

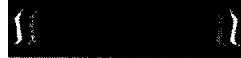
