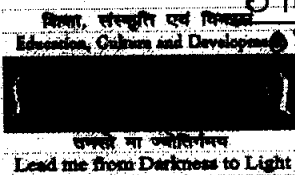



ORDER

No. 5/29-2009 HRGF(1)

Dated: 15-1-13

Brief facts of the case are that FIR No. 5 dated 30.01.2006 under Sections 323, 325 and 34 IPC at PS Babain (Kurukshetra) was registered against Shri Balwant Singh, Principal, Government Senior Secondary School Prahladpur (Kurukshetra) on the complaint of Shri Ram Kumar of giving beatings and threatening to kill him. Additional Sessions Judge, Kurukshetra vide order dated 29.09.2010 convicted the said accused and sentenced them to undergo rigorous imprisonment for a term of three months under Section 323 and rigorous imprisonment for a term of six months and a fine of Rs.1000/- under Section 325 of IPC. In criminal appeal No. 2452-SB of 2010, Hon'ble Punjab and Haryana High Court vide order dated 12.10.2010 has suspended the said sentence during the pendency of the appeal.

As per instructions issued by Chief Secretary to Govt. of Punjab vide letter No. 4819-G II-57//11919 dated 08.07.1957, if a Government Servant is convicted of charges involving moral turpitude, he should be dismissed or removed from Government service and the filing of the appeal should not deter from inflicting a suitable punishment as provided in proviso (b) to Sub Rules (2) of Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987. Further, vide instructions No. 1449-5GSI-75/6324 dated 17/26.03.1975 issued by Chief Secretary to Govt. Haryana, the following tests should ordinarily be applied in judging whether a certain offence involves moral turpitude or not: -

- (a) Whether the act leading to a conviction was such as could shock the moral conscience of society in general.
- (b) Whether the motive which led to the act was base one.
- (c) Whether on account of the act having been committed the perpetrator could be considered to be of depraved character or a person who was to be looked down upon by the society.

It has been further conveyed vide said instructions that decision in each case will, however, depends upon the circumstances of the case and the competent authority has to exercise its discretion while taking a decision in accordance with the above mentioned principle. Further, from the perusal of the list of offences which involve moral turpitude, enclosed with the said instructions, it is clear that none of the offences committed by the incumbent fall in the category of moral turpitude.


Further, in para 14 of Law and Legislative Department guidelines regarding procedure in disciplinary cases, it has been provided that the punishing authority has to

inflict a punishment of dismissal/removal/compulsory retirement or some other minor punishment keeping in view whether the conduct relates to moral turpitude or not.

After going through the Additional Sessions Judge, Bhiwani order dated 29.09.2010, Hon'ble Punjab & Haryana High Court order dated 12.10.2010, various instructions detailed above, various provisos to Article 311(2) of Constitution of India and connected provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987, it is clear that the offences do not fall under 'moral turpitude' in any way, especially in view of the fact that the act leading to conviction is not such as could shock the moral conscience of society in general, nor the incumbent could be considered to be looked down by the society by the said act.

Taking a holistic view, a penalty of stoppage of three grade increments with cumulative effect is inflicted upon Shri Balwant Singh, Principal, Government Senior Secondary School Prahladpur (Kurukshetra).

I order accordingly.

ORDER NO. 5/155-2008 HR&ED Dated, Panchkula, the 5-2-13

Whereas Hon'ble Punjab and Haryana High Court in CWP No. 3556 of 2012 titled as Shadi Lal Vs. State of Haryana and others vide order dated 25.02.2012 has directed as under: -

"Without going into the merits of the case or commenting thereon, this writ petition is disposed of with a direction to the Financial Secretary and Principal Secretary to Government of Haryana, School Education Department, Haryana - Respondent No. 1 to consider the legal notice dated 18.11.2011 (Annexure P-13) and decide the same within a period of three months from the date of receipt of the certified copy of this order. Decision so taken thereon be conveyed to the petitioner forthwith."

Brief facts of the case are that Shri Shadi Lal, Block Education Officer (BEO) (Retd.) was chargesheeted vide order dated 04.03.2009 under Rule 7 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 as under: -

1. The said incumbent did not handover the charge of the School after transfer from 21.12.2007 till 06.02.2008.
2. He has kept an amount of Rs.1,23,527/- as a cash in hand out of the government funds from 06.02.2008 to 16.09.2008.
3. He has diverted funds from various heads i.e. health fund, amalgamated fund to building fund.
4. He has spent an amount of Rs.12,20,000/- and Rs.3,50,000/- without obtaining the approval of the competent authority.


Finding his reply to the said chargesheet as unsatisfactory, Sh. M. K. Midha, IAS (Retd.) was appointed as regular Inquiry Officer (IO), who has proved the charges against the said incumbent. IO has further observed that the mode and manner in which the purchases have been made and works executed clearly violate the protocol and procedure prescribed for such purchases. It has been further observed that FIR registered against the incumbent be also need to be perused vigorously and impressed upon to take the matter to the logical conclusion on priority. However, Hon'ble Punjab and Haryana High, in Criminal Misc. No. M-9561 of 2010, vide order dated September 1, 2010 has exempted personal appearance of the petitioner before the trial court.

Thereafter, after agreeing with the report of the IO and as per Rule 7(6) of the Haryana Civil Services (Punishment and Appeal) Rules, 1987, a copy of the inquiry report was sent to said incumbent to make a written representation, if he so desires, within a period of one month. The said representation was received on 02.09.2010 and he was heard in person on 09.03.2011.

After going through the contents of representation and by hearing in person, the following penalties were imposed upon him vide order No. 5/155-08 HRG-I(1) dated 17.08.2011 after obtaining approval of Haryana Public Service Commission, in view of Rule 2.2(b) of Punjab Civil Services Rules, Volume II regarding withholding or withdrawing the pension or to effect recoveries:


1. Recovery of Rs.12,20,000/- plus Rs.3,50,000/- i.e. Rs.15,70,000/- be made from the retiral benefits i.e. gratuity, commutation of pension and leave encashment of the incumbent.
2. 5% cut in pension.

As a consequence of the same, the said incumbent filed a CWP No. 3556 of 2012 titled as Shadi Lal Vs. State of Haryana and others in Hon'ble Punjab and Haryana High Court, who vide its order dated 25.02.2012, as enunciated above, has directed to decide the legal notice dated 18.11.2011. The said incumbent was heard in person on 06.09.2012, who vide his written arguments stated that he has obeyed the transfer orders and Rs.1,23,527/- was used for the material. Regarding spending Rs.15,70,000/- without the sanction of the competent authority, he submitted that he constituted a committee and the proceedings of the said committee were approved by Additional Deputy Commissioner, Hisar. He specifically emphasized that the amount, in question, were used by seeking approval of higher authorities. He also annexed some relevant documents in support of his written submissions dated 06.09.2012.

 From the perusal of the file, it has also been found that during his posting afterwards as BEO Punhana, an another FIR No. 40 dated 16.06.2010 has been lodged at PS Punhana (Mewat) for embezzling an amount to the tune of Rs.4,34,270/-. Further while having drawing and disbursing powers of Principal, Government Senior Secondary School Punhana (Mewat), accounts to the tune of Rs.27.11 Lac, pertaining to the construction of computer lab and other rooms, have not been settled till date.

After going through the contents of legal notice dated 18.11.2011, orders of Hon'ble High Court dated 25.02.2012, submissions made at the time of personal hearing on 06.09.2012, connected provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987 and facts enunciated above, There is not a scintilla of doubt that the incumbent has misused the powers, vested in him, blatantly against the canons of financial propriety and the statutory financial rules applicable for making purchases and incurring other expenditure. Moreover, a teacher is expected to set high standards of integrity, probity and rectitude, which the incumbent has been lacking, without an iota of doubt. Even after his transfer from Government Senior Secondary School Bass (Hisar), the incumbent was found involved in financial irregularity, while being posted as BEO Punhana and also holding the DDO powers of Government Senior Secondary School Punhana, as detailed above.

Taking an overall view of the matter, the legal notice dated 18.11.2011 is rejected, being devoid of any merit.
