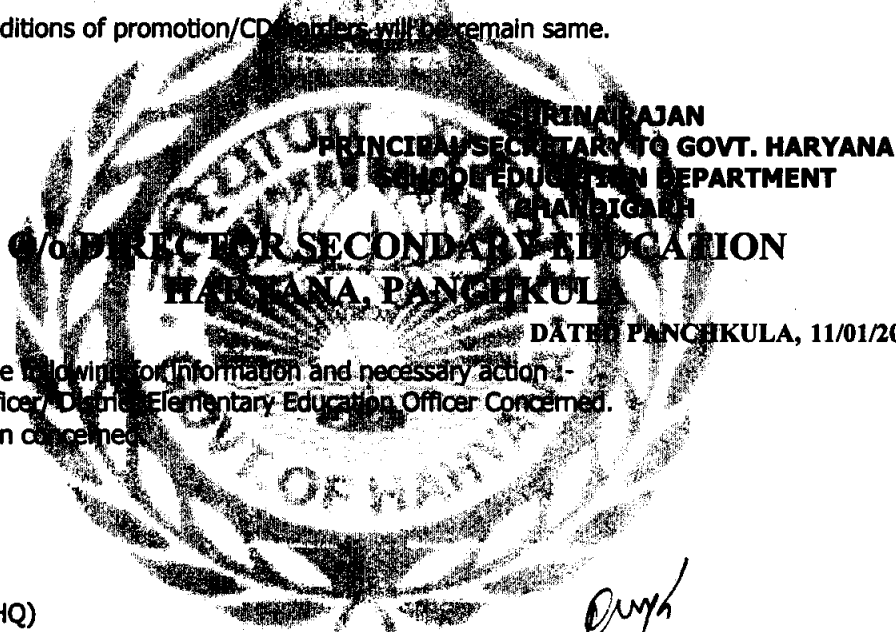

If any discrepancy is noticed in this order or there is violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8km.
- In case of urban area staff, while implementing the transfer policy, it may be ensured that the transferee has completed the rural service as per transfer policy.
- The mutual transfer would be effective only if both the employees seeking mutual transfer submit a consent document to their respective Principals.

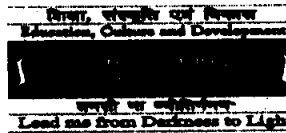
