Whereas a CWP No. 5874 of 2012 was filed by Smt. Usha Gandhi in the Hon'ble High Court praying therein for issuance of a writ in the nature of mandamus for directing the respondent to promote the petitioner on the post of Economics Lecturer w.e.f. 04-12-2008 from the date of her Juniors. This writ petition was disposed of by the Hon'ble High Court vide its order dated 29-03-2012 with direction to decide the representation dated 20-12-2008 and 24-07-2010. The operative part of the order is reproduced here as under:


"Without going through the merits of the case or commenting thereon, this writ petition is disposed of with the direction to the Commissioner and Director General, School Education, Haryana- Respondent no. 2 to consider the representation dated 20.12.2008 (Annexure P-1) and representation dated 24-07-2010 (Annexure P-2) and decide the same within a period of three months.

In case the petitioner is held entitled to the claim as made through her representations, consequential benefits, if any, be released to her within a further period of two months, in accordance with law."

In view of the directions of the Hon'ble High Court, the representation of the petitioner were perused and examined at length. After examination of the case of the petitioner, it was found that the petitioner has prayed for promotion for the post of Economics Lecturer from the date her junior Sh. Ranvir Singh was promoted. Sh. Ranvir Singh was promoted as Lecturer of Economics on 04-12-2008 whereas the petitioner had already been promoted to the post of Economics Lecturer vide office order no. 15/354-2007 HRL (2) dated 28-11-2007 at serial no. 4, but the name of the petitioner was inadvertently mentioned as Usha Rani Master Mathematics G.G.H.S. Karnal instead of Usha Gandhi Maths Mistress G.H.S. Noorwala, District Panipat. So due to clerical mistake the petitioner cannot join as Economics Lecturer.

Now, the order of promotion of the petitioner has been rectified and substituted order has been issued to her, stating therein the date of her promotion as Economics Lecturer w.e.f. 28-11-2007 (i.e. before the date of her junior Sh. Ranvir Singh who was promoted on 04-12-2008) with all consequential benefits.

I, order accordingly.

Sh. Sonu, Clerk, (ID No. 093073) District Education Office, Panchkula is hereby selected for temporary appointment as Clerk in the O/o Director General Secondary Education Haryana, Panchkula on transfer basis in the grade of Rs. 5200-20200+G.P. 1900/-.

His pay will be fixed in the grade according to rules. He will also draw the usual allowances admissible to Govt. Servants of their categories issued from time to time.

His appointment in the O/o Director General Secondary Education Haryana, Panchkula will be on the following terms and conditions:-

1. His appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. As such, as and when there will be no vacancy against which he could continue to officiate in the Directorate of School Education Haryana, he will be reverted to his parent office. It is, thus made clear to him that at present he has been offered temporary post.
2. He will be required to take the prescribed oath of allegiance to the Constitution of India.
3. In case he is unmarried, he shall have to furnish a declaration to the effect that he will not have more than one living spouse.
4. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the prosecution of higher studies.
5. If, he has not been vaccinated within last twelve months he should have done it before reporting himself for duty.
6. In case at any stage, while he remains in temporary capacity desires to resign his post in the O/o Director General Secondary Education, Haryana, Pnackula, he will be required to give one month's notice or forfeit in lieu thereof salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Department also in case it is proposed to terminate his services for reasons other than those mentioned in para-I above. The Department will also be liable to pay salary including allowances for one month or for the period by which the notice falls short of one month. In case of misconduct, however, he will be entitled to a reasonable opportunity to show cause notice as to why his services should not be terminated, in that case the condition of one month's notice shall not apply. His services will be governed by the Haryana Education Directorate (State Service Class-III), Rules 1974, Haryana Civil Services (P&A) Rules 1987 and Employees Conduct Rules 1966 as amended from time to time etc.
7. He will be on probation for a period of one year from the date of joining. If his work and conduct is not found satisfactory, he will be reverted to his parent cadre without giving any notice to him.
8. In case he is married, he would have only one living spouse, if he has more than one living spouse, he should justify for that.

9. He will be given seniority as per Rule 11 of the Haryana Education Directorate (State Service Class-III), Rules 1974, as amended from time to time. He will be assigned seniority from the date he joins in the Directorate and will be placed at the tale-end of the employees already appointed in the Directorate.
10. If he has passed the type test already as per his service condition in his parent Department, he would get increment usually provided that there should be entry in this regard in his service book. Otherwise, he will have to pass type test in Hindi/English at the speed of 25/30 words per minute respectively within a year after joining in the Directorate. Till he pass the said type test he will not be allowed increment until he passes such test. After passing the type test he will be allowed the due annual increment (s) following the date from passing the test but no arrear will be allowed.
11. His services will be governed under the New Pension Scheme of the Haryana, Government.
12. No T.A/D.A. will be allowed to him for joining this post.

If he is willing to accept the offer made on the above mentioned conditions, he may get himself be relieved and report for duty to the O/o Director General Secondary Education Haryana, Shiksha Sadan, Sector-5, Panchkula within a period of 15 days from the date of issue of this letter.
