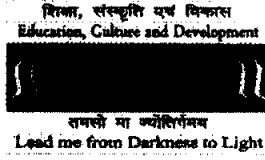

Shri Attar Singh, the then Principal, Govt. Senior Secondary School Badhra (Bhiwani), now posted at Govt. Senior Secondary School Sangwan (Bhiwani) was chargesheeted under Rule 7 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 vide order No. 5/93-11 HRG-I(1) dated 25.01.2012 on the following charges and allegations: -

1. Payment to the tune of Rs.47,857/- has been made out of various funds but the material has not been received.
2. Rs.58,390/- has been kept in cash by withdrawing the said amount from various funds.
3. Embezzlement to the tune of Rs.12,99,638/- has been done by withdrawing the amount from various funds, showing excess expenditure than the actual as assessed.
4. Mis-utilization and wasteful expenditure of Rs.94,812/- pertaining to various funds has been done as the purchased articles were not required at all.
5. All the funds of the school were kept in his personal custody whereas it was incumbent upon him to allocate each fund to different incharges.
6. No Committee was constituted for the construction of rooms and other works whereas the same was required as per instructions issued by the Government from time to time.


He replied to the said chargesheet on 26.02.2012 (received on 05.03.2012). Finding the same as unsatisfactory, Shri R. K. Taneja, IAS (Retd.) was appointed as regular enquiry officer. The said enquiry officer vide his report dated 18.10.2012 has observed regarding charge No. 1 that the incumbent has failed to follow the procedure regarding purchase and material had to be refused or not received, but no embezzlement was involved. Regarding charge No. 2, it has been held that the incumbent has not obtained approval of competent authority before diverting funds under other heads and hence, has committed irregularities in the use of funds under other heads. Regarding charge No. 3, it has been concluded that the incumbent is guilty of unauthorized claim of having spent from his pocket to the tune of Rs.2,49,842/- and the said amount should be considered as wrongfully held by him in his custody till the same was returned to exchequer and this refund falls under the category of temporary embezzlement. Regarding charge No. 5, it has been held that the charge of keeping all the funds of the school in his personal custody is proved. Accordingly, a communication dated 19.11.2012/12.12.2012 along with a copy of the inquiry report was sent to the said incumbent to make a written representation within a period of one month, if he so desired. Reply of the same was received on 07.01.2013, wherein regarding No. 1 he admitted that there was irregularity in applying government procedure in purchase of items, however, he had deposited the amounts in respective heads and prayed to be exonerated. Regarding charge No. 2, he admitted that for completing the work in time, necessary withdrawal was made and requested to be exonerated. Regarding charge No. 3, he admitted that an amount of Rs.2,49,842/- were not kept in his personal custody, but the said amount was deposited on 14.07.2011, 18.07.2011, 19.07.2011 in the funds from which amount was utilized to meet out the gap of Twelfth Finance Commission (TFC) grant and prayed to be exonerated. Regarding charge No. 5, he submitted that the powers have been delegated to the respective teachers/incharges of the funds, but the copy of the order could not be shown at the time of the inquiry.

Hay

I have gone through the contents of chargesheet, reply thereof, report of regular enquiry officer, written representation in consequence thereof and connected provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987. From the perusal of the above, it is clear that the incumbent has blatantly violated cannons of financial propriety, financial rules and funds have been diverted from various heads in a very callous manner. Depositing of Rs.2,49,842/- from his own pocket further casts reflection in the matter.

Taking an overall view of the matter, a penalty of stoppage of three grade increments with cumulative effect is imposed upon Shri Attar Singh, the then Principal, Govt. Senior Secondary School Badhra (Bhiwani), now posted at Govt. Senior Secondary School Sangwan (Bhiwani), as provided in Rule 4(i)(v-A) of Haryana Civil Services (Punishment and Appeal) Rules, 1987.
