

Shri Ravinder Pal Singh, Principal, Government Senior Secondary School Akbarpur (Ambala) was placed under suspension on 18.01.2012 and reinstated at Government Senior Secondary School Majri (Ambala) on 10.01.2013 in compliance of the orders dated 20.12.2012 passed by Hon'ble Punjab and Haryana High Court in CWP No. 1634 of 2012. Meanwhile, he was chargesheeted under Rule 7 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 vide order No. 5/10-2012 HRG-I (1)/2157 dated 21.06.2012 on the following charges and allegations: -

1. That in the year 2011-12, grant of Rs.23,600/-, which was received by the School on 03.05.2011 for distribution of uniform, shoes etc. amongst the students of Class VI to VIII, has not been given to the students till date.
2. That in the year 2010, the examination fees of VIII class, given to the Board on 22.05.2010, has been returned to the school due to cancellation of the said examination, but the same has not been refunded to the students till date. The said amount of Rs.4,386/- is continuing in Saving Bank Account since 14.12.2010.
3. That grant of Rs.1.00 Lac was received by the School on 16.12.2009, sent by District Education Officer Ambala pertaining to maintenance of ground, which was to be utilized by constituting a committee of one Senior Lecturer and PTI of the School. It is clear from the perusal of the Bank Statement of Account No. 11088425352 that he withdrew the said amount on 26.03.2010 from the Bank and deposited the same on 24.05.2010 in the same account. There is no purpose mentioned anywhere regarding the said withdrawal and deposit.
4. That entry of Rs.60,000/- was shown in the Cashbook as paid to Ravinder Singh for Mid Day Meal from Sanchaika Fund, whereas it was shown as paid to Sh. Rajinder Singh in the passbook of Sanchaika Fund. The said amount was not account for in the Mid-Day-Meal Account, which is a financial irregularity.
5. That from April, 2010 to October, 2010, fees of students of Classes VI to VIII was to be refunded to students as per Government instructions, whereas as per office record, the refund of the same has not been done till date.

He replied to the said chargesheet on 18.12.2012, wherein he stated regarding charge No. 1 that amount of Rs.23,600/- could not be spent due to holding of dual charge of the present school as well as Government Senior Secondary School Naraingarh (Ambala), in addition to vacancy of Clerks in the said schools. Regarding charge No. 2, he cited the same reasons as regards charge No. 1. Regarding charge No. 3, he stated that amount of Rs.1.00 Lac, withdrawn from the bank on 26.03.2010, could not be spent due to continuation of vigilance enquiry in the matter. Regarding charge No. 4, he stated that he has spent Rs.66,778/- from his own pocket and as a consequence of the personal necessity, Rs.60,000/- were withdrawn from the Sanchaika Fund and further, after receipt of grant of Mid-Day-Meal, the said amount was deposited back in Sanchaika Fund. Regarding charge No. 5, he cited the same reasons as regards charge No. 1.

I have gone through the contents of chargesheet, reply thereof and connected provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987. It is clear that the incumbent has failed to perform his duties regarding charge No. 1, 2 and 5. Further, the incumbent has violated the canons of financial propriety by withdrawing funds from Sanchaika Fund, irrespective of

the fact whether the same has been spent earlier from his own pocket. Furthermore, regarding charge No. 3, the said incumbent has withdrawn Rs.1.00 Lac from Government exchequer without visualizing arrangements for spending the same forthwith and deposited back the said amount after a lapse of about two months on 13.05.2010. Thus, the incumbent is responsible for the lapses enunciated above.

Taking an overall view of the matter, a penalty of stoppage of one grade increment without cumulative effect is inflicted upon Shri Ravinder Pal Singh, the then Principal, Government Senior Secondary School Akbarpur (Ambala), now posted at Government Senior Secondary School Majri (Ambala), as provided in Rule 7(2)(e) read with Rule 4(1)(v) of Haryana Civil Services (Punishment and Appeal) Rules, 1987.

Earlier Smt. Paramjit Sharma, the then BEO, Shahzadpur (Ambala) was charge-seated under rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987, on 17.07.2012 on the following charges:-

1. That an amount of Rs. 5,46,000/- which was released by the DEEO, Ambala for purpose of earthing, grill and curtains for the school under EDUSAT Scheme, she draw an amount of Rs. 94900, 328500, 107845 and 14200 from the ac. and issue cheques. No name of the person or firms was mentioned as per records available in office.
2. That she collected the amount by selling book @ Rs. 700/- namely 'Development of Industries in Punjab, Haryana and Himachal Pradesh' written by her school teachers of the schools.
3. That she collected an amount of Rs. 500/- for stitching of curtains under EDUSAT Scheme from the teachers of each school and did not complete the work of curtains in the schools.

She submitted reply of the charge-sheet on 10.08.2010 and after considered her reply, a show cause notice was issued to her vide memo no. 5/44-2007 HRG-I(1) dated 14.10.2011 to explain her position regarding purposed punishment of stoppage of 5 annual increments without community effect. Whereas no show cause notice is required for the proposed punishment to decide charge-sheet issued under rule 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987.

She was afforded an opportunity of personal hearing on 29.06.2012, 16.07.2012, 13.08.2012, 11.09.2012, 21.11.2012 and 19.12.2012 by the then Director Secondary Education, Haryana. Ultimately, she was granted an opportunity of personal hearing on 05.02.2013 at 3.00 pm by the undersigned to explain her case. She submitted her reply to the show cause notice on 31.01.2012

Today, she appeared before the undersigned and submitted written evidence in her favour. She has reiterated the facts/submissions already submitted 06.01.2012 through her counselor and further submission in detail on 29.06.2012 and another submission on 28.08.2012 through DEO Ambala. She has pleaded that the charge sheet issued to her on 17.07.2010 and show cause notice dated 14.10.2011 are violation of the orders passed by the Hon'ble High Court in CWP No. 4496 of 2007 and COCP No. 735 of 2012 decided on 03.08.2012. During the pendency of CWP No 4496 of 2007, nothing has been found against her during enquiry and as such Financial Commissioner and Principal Secretary to Govt. Haryana, School Education Department posted her as Dy. DEO Ambala on 29.07.2007. The Hon'ble High Court kept her right of salary alive for the suspension period when CWP No. 4496 of 2007 was disposed off on 14.02.2008. The Financial Commissioner & Principal Secretary to Govt. Haryana, School Education Department vide order no. 7/109-2002 HRG(1) dated 31.08.2006 revoked the suspension orders of Smt. Radha Rani, Principal, GSSS Raipur Rani (Panchkula) on the ground that charge-sheet was not issued to her even after lapse of more than three years and her suspension period was treating as duty period for all intents and purposes.

She has further stated that no copy of preliminary enquiry report was ever supplied to her. No documents supplied with the charge sheet. The chief Accounts who conducted enquiry never associated her in the enquiry proceedings and therefore, his

enquiry report is liable to be ignored. No witness was examined in her presence. So her right to cross-examine the witness has been denied and taken away tantamount to violation of principle of natural justice. No copy of complaint by teachers forcing them to purchase her books was ever supplied. No list of witnesses and documents to be relied upon were ever supplied to her by the department which again tantamount to violation of principle of natural justice and rules of enquiry proceedings. It is well-settled law laid down by a full Bench of High Court that even for imposing minor punishment under rule 8, a full fledged enquiry is required to be conducted which has not been conducted in the case.

She has further stated regarding charge No.1 that the grant of Rs.546000/- received for EDUSAT in 73 Primary schools for grills, earthing and curtains was received vide letter no. 7/31/119 dated 25.01.2007. The work was to be completed within a week and utilization certificate was to be submitted to DEEO Ambala after completing the works.

In compliance of the above orders, a committee consisting of following officers was constituted for getting the work completed:-

- (i) Principal GSSS Bharog, Jatwar, Sheehzadpur(Boys), Korwa Khurd, Kakkar Majra, Rai Walli.
- (ii) Headmaster of GHS Khanpur Brahaman, Danana etc.

The committee collected quotations, prepared comparative statement. After consideration, orders were placed for the good quality with lowest bidder for grills, earthing and curtains as per details below:-


All relevant documents are available in the record of BEO, Shahzadpur (Ambala).

As regards charge No.2, she has stated that this charge is absolutely false, baseless and fictitious. No amount was received by her from anybody nor was any book given to anybody by her. She has issued no receipt under her signature.

As regards charge No.3, she has stated that this charge is absolutely false, baseless and fictitious. No amount was taken from anybody for stitching of curtains. She has issued no receipt under her signature.

During the course of hearing, she has further stated that there is a stay granted by the Hon'ble High Court, regarding disciplinary proceedings pending against her. But she failed to provide any substantial proof in this regard and the undersigned was not agreed with her plea.

After going through the relevant record of the case, reply to the charge-charged show cause notice and the written evidence dated 05.02.2013, it has been found that the



that the charges levelled against her regarding disbursement of cheques of the amount of Rs.94900, 328500, 107845 and 14200 from the account and issued cheques out of total grant of Rs. 5,46,000/- released by the DPEO Ambala for the purpose of earthing, grill and curtains for the school under EDUSAT Scheme could not be proved as she has shown the copy of the cheques and encashment of the same by the concerned firm from concerned bank. Such record should be in the office of BEO concerned.

Further, as regards charge no. 2 i.e. selling of a book @ Rs. 700/- to the teachers of the schools as alleged to be written by her in the charge sheet and another charges regarding collection of Rs. 500/- as stitching charges of the curtains under EDUSAT Schemes also could not be proved in the absence of any documentary proof in this regard. It was also claimed by her that no book has been written by her and title mentioned in the allegation is merely topic of her Ph.D. thesis. Some of the persons who gave the statement to CAO are even retired and so it seems that they have given the statements under pressure from some external authority within the department. I do not have any evidence to suggest malafide intention of the charged officer in making purchases at per allegation No.1 and other allegations at Sr.No.2 & 3 are also not proved.

Therefore, after considering all the facts, circumstances and contentions put forth by the charged-officer in reply to the charge-sheet and show cause notice, pleadings made during personal hearing and findings of the enquiry report as well as the peculiar and adverse circumstances through which she was passing, I feel that due to non availability of authentic proof with regards to collection of money for selling of book and stitching of curtains, she deserves to be exonerated of the charges levelled against her vide memo no. 5/44-2007 HRG-I(1) dated 17.07.2010 charge sheet under rule -8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987.


