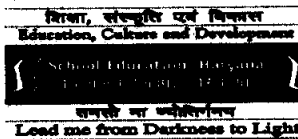

In exercise of powers conferred under Rule 29 (3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfill the required conditions.

This letter of permission is based on the undertaking given by the applicant as per details given overleaf. Any violation of the undertaking automatically nullifies the permission. This permission is further subject to 'No Objection' from the 'Competent Authority' regulating the land use of the proposed site.

The permission to add new proposed classes for higher stage is only 'In-principle' approval of the Education Department to allow applicant to initiate steps and provide infrastructure to the new proposed classes of higher stage.

Students should not be admitted only on this permission without getting recognition. The recognition will be granted R.T.E. Rules-12 Appendix-II by the Department on fulfillment of prescribed norms as provided in Haryana School Education Rules-2003, in the interest of safety, health and welfare of students and other requirements.

Whereas Sh. Murari Lal had filed CWP No. 13476 of 1994 (O&M) in the Hon'ble Punjab & Haryana High Court and prayed therein to grant pay/salary with effect from 01.04.1991 to 05.04.1992. Secondly that he be granted seniority with effect from 25.10.1985 i.e. the initial date of appointment along with increments etc.

The above cited writ petition was disposed of vide order dated 26.11.2012 and the operative part of the order is reproduced below :-


"Upon an appraisal of the material on record, I am of the opinion that the prayer of the petitioner for grant of salary from 01.04.1991 to 05.04.1992 cannot be granted in his favour for the reason that he was involved in a criminal prosecution and he did not work for this period. He was however, entitled to all other consequential benefits except the monetary ones.

Reply filed by the respondents qua the second aspect of the matter regarding grant of seniority is totally silent on this issue.

Therefore, the petition is disposed with a direction to the respondents to consider the claim of the petitioner regarding grant of seniority and pass an appropriate order in this regard. The prayer of the petitioner for pay is negated."

In compliance of order dated 26.11.2012 passed by the Hon'ble High Court in CWP No. 13476 of 1994, the claim of the petitioner regarding grant of seniority has been considered and found that the petitioner had served on adhoc basis from the year 1985 to 1988 but the benefit of seniority by adding the adhoc service cannot be granted as the same issue has now been decided by the Hon'ble Apex Court in SLP No. 29274 of 2009 titled as State of Haryana Vs. Vijay Singh & others. Therefore, the claim of the petitioner deserved to be rejected.

I pass order accordingly.
