The above sanction is subject to fulfillment of following conditions:-

- 1. The grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- 2. The school shall by the provisions of Right of Children to Free and Compulsory Education Act. 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
- The school shall admit in class I, to the extent of -- the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion:

 Provided, that in case of pre primary classes also, this norm shall be followed.
- For the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.

5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.

The school shall not deny admission to any child for lack of age proof If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.

The school shall ensure that :-

- (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
- (ii) no child shall be subjected to physical punishment or mental harassment;
- (iii) no child is required to pass any board examination till the completion of elementary education.
- (iv) every child completing elementary education shall be awarded a certificate as laid down under rule 22;
- (v) inclusion of students with disabilities /special needs as per provision of the Act;
- (vi) the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not posses minimum qualifications shall acquire such minimum qualification within a period of 5 years;

- (vii) the teacher performs its duties specified under section 24(1) of the Act; and (viii) the teachers shall not engage himself or herself for private teaching activities.
- 7. The school shall follow the syllabus on the basis of curriculum laid down by academic authority.

8. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.

- 9. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:
 - (i) Area of school campus total built up area.
 - (ii) Area of play ground
 - (iii) Number of class rooms
 - (iv) Room for Headmaster-cum-Office-cum-Storeroom

- 11. The school buildings or other structures or the grounds are used only for the purposes education and skill development.

The school is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force.

The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the statements of accounts should be sent to the District Elementary Education Officers every year.

Present case is the outcome of imposing a penalty of 'Censure' by Director Secondary Education (DSE), Haryana vide order dated 13.09.2012/25.09.2012 in a disciplinary matter under Rule – 7 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 upon Shri Om Parkash, Deputy Superintendent (Retired), whereas, no such penalty can be imposed upon a retired person and decision has to be taken under Rule 2.2(b) of CSR, Volume II. Accordingly, a decision was taken to take suo moto notice and call for and examine the records of the case, as provided in Rule 14(1) of Haryana Civil Services (Punishment and Appeal) Rules, 1987.

Brief facts of the case are that Shri Om Parkash, Deputy Superintendent (Retired) was placed under suspension on 10.09.2007/17.09.2007 and reinstated on 19.02.2008. Further, the said incumbent was chargesheeted under Rule 7 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 on 30.03.2010 on the following charges: -

- 1. Excess withdrawal from Bank/disbursement of Rs.10,000/- (Rs. Ten Thousand) resulting in non-accountal in violation of PFR Rules.
- 2. Non-Closure of the cash book during the month of 3/06 in violation of PFR Rules.
- 3. Violation of provisions contained in Government Employees Conduct Rules, 1966.

He replied to the said chargesheet on 23.04.2010 and finding his reply as unsatisfactory, Shri V. P. Batra, IAS (Retd.) was appointed as regular enquiry officer, who vide his report dated 09.08.2012 has not proved said charges clearly, but made a observation regarding charge No. 1 that Rs.10,000/- has been drawn in excess and disbursed erroneously to the Head Master, Government Primary School (GPS) Karandi on 16.01.2006. It was further stated that the said amount was received back on 16.01.2006 itself and deposited in RD accounts in post office on 20.01.2006. It was specifically mentioned that there was no appropriation. Regarding charge No. 3, it was mentioned that though there was no appropriation, yet back entry of Rs.10,000/-, as enunciated above, has not been made in the cash book. Thus, it is clear that there was no charge of any type of embezzlement or other illegality. Director Secondary Education, Haryana vide order dated 13.09.2012/25.09.2012 has concluded that no charge has been proved. However, he has imposed a penalty of 'Censure' upon the said incumbent,

whereas there is no such provision to impose the above said penalty upon a retired person. It would have been appropriate for him to have decided the case under Rule 2.2(b) of CSR Volume II, in case a penalty is to be imposed.

Hence, being contrary to provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987 and Civil Services Rules, Volume II, the case was called for and examined under Rule 14(1) of the said Rules of 1987. Accordingly, the incumbent was heard on 22.05.2013. During hearing, he stated that he has been absolved of the charges levelled against him and hence, there was no justification of imposing a penalty of censure, especially in view of the fact that on the date of passing of the said order dated 13.09.2012/25.09.2012, he has retired from the service.

I have gone through the chargesheet dated 30.03.2010, enquiry report dated 09.08.2012, DSE order dated 13.09.2012/25.09.2012, submissions made at the time of hearing and relevant provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987 and Civil Services Rules, Volume II. In this case, from the perusal of enquiry report, it is clear that there is no embezzlement of any type and in addition, there is no material irregularity and only a minor lapse of payment of Rs.10,000/- erroneously made to Head Master, GPS Karandi, which has been recovered on the same day. Hence, the incumbent is not primarily responsible for any of the charges.

Taking an overall view of the matter, Shri Om Parkash, Deputy Superintendent (Retired) is absolved of all the charges levelled against him. Accordingly, suspension period from 17.09.2007 to 19.02.2008 shall be treated as duty period for all intents and purposes and the incumbent is entitled for full pay and allowances for the said suspension period, as provided in Rule 7.3(2) of CSR Volume-I, Part I.

I order accordingly.
