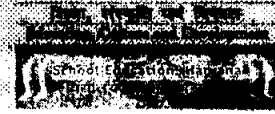



Disciplinary matter of Shri Naresh Kumar, Principal, GSSS, Bichpori (Sonipat) previously Block Education Officer, Beri (Jhajjar) was decided vide order No. 5/1-08 HRG I (1) dated 16.03.2012 and the following penalties were inflicted:-

1. Rs.1,07,048/- be recovered, being one forth of 50% of total financial loss of Rs. 8,56,380/-.
2. Penalty of 'Censure' as provided in Rule 4(1) (ii) of Haryana Civil Services (Punishment & Appeal) Rules, 1987.

For deciding the suspension period from 01.01.2008 to 04.03.2008, a show cause notice, to be replied within fifteen days, was issued vide Memo No. 5/1-08 HRG I(1) dated 06.07.2012 on the following grounds:-

1. Why the pay and allowances for the suspension period be not restricted to whatever have been paid during the suspension period?
2. Why the suspension period be not treated as non-duty period?

In consequence thereof, he made representation dated 30.07.2012 wherein he stated that as the department has already ordered recovery against him, hence, the restriction of pay and allowances including treating the suspension period as non duty period would tantamount to double jeopardy and the same is in violation of service jurisprudence. Finally, he prayed that his case be re-examined sympathetically and his suspension period be treated as duty period with all financial allowances and benefits.


After going through the representation, relevant provisions of The Punjab Civil Services Rules, Volume I, Part I and Government instructions issued from time to time in this regards, it is clear that the incumbent has not been fully exonerated in the departmental proceedings and Penalty of 'Censure' as provided in Rule 4(1) (ii) of Haryana Civil Services (Punishment & Appeal) Rules, 1987 alongwith recovery as detailed above has been inflicted upon the incumbent.

Hence in view of Rule 7.3(3) of CSR Vol. 1 Part 1, the incumbent shall be entitled for pay and allowances, restricting the same to whatever has been paid to him during the said suspension period from 01.01.2008 to 04.03.2008. Further, the period of suspension from 01.01.2008 to 04.03.2008 shall be treated as duty period for all other purposes.

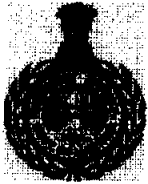


Whereas, Smt. Anju Yadav, the then <sup>Principal</sup> GSSS, Nangali Godha Rewari was charge sheeted under Rule-8 of Punishment & Appeals rules, 1987 vide order No. 5/182-2010 HRG-I (1) Dated 27.07.2012.

She replied to the charge sheet vide representation dated 3.9.2012 and denied the charges.

The delinquent officer has retired voluntarily from service on 31.8.2012, but decision regarding the charges leveled against her could not be taken till her retirement. Even if at this stage she is held guilty for minor punishment, it can not be made effective because for minor punishment either an increment of the delinquent can be stopped or she may be warned for lapses, but both these punishments can not be imposed at this stage, thus, there appears no justification to proceed further in this matter.

I have gone through the relevant record of the case and found that keeping in view of the facts and circumstances of the case and taking into the consideration these facts that Smt. Anju Yadav has already retired voluntarily from service on 31.8.2012. Therefore, I, pass an order to drop the charge-sheet under rule-8 against Smt. Anju Yadav.

I order accordingly.
