**Revision of Pension/Family Pension/Enhanced Family Pension and Death-cum-retirement Gratuity for the retirees of Privately Managed Government Aided-Schools consequent upon the recommendations of 6<sup>th</sup> pay commission with effect from 1.8.2011.**

Refer to the subject cited above.

It is informed that in exercise of the powers conferred upon by me under rule 23 of Haryana Aided-School (Special Pension and Contributory Provident Fund) Rules 2001(amended), the Governor of the Haryana is pleased to introduce following modifications in the rules regulating Pension, Family Pension, Enhanced Family Pension and Death-cum-retirement Gratuity for the retirees of Privately Managed Government Aided-Schools in the State consequent upon the recommendations of 6<sup>th</sup> pay commission with effect from 1.8.2011.

**Pension**

**(1) Pension/Family Pension before 1.1.2006 shall regulate as under:-**

For existing Pensioners/Family Pensioners

- (i) From 1.1.2006 the calculation formula will be basic pension/family pension +Dearness Pension+D.A.@24% + Fitment weightage 40% i.e. 2.26 of basic pension/family pension.
- (ii) Minimum Pension/ family pension in no case be less than Rs. 3500/- per month in all cases irrespective of length of qualifying service or otherwise.

**(2) Pensioners retired on or after 01.01.2006 but not later than 31.07.2011 shall regulate as under:-**

**Pension**

Pension of such retirees shall regulate by taking the average emoluments of last 10 months pay in revised pay structure in the prescribed Pay Band Plus applicable grade pay entitled from 01.01.2006 under the existing pension calculation formula as provided in the Haryana Aided-Schools(Special Pension & Contributory Provident Fund) Rules, 2001(amended).

Provided when a cause so arise in the case of retirees retired between 01.01.2006 to 30.09.2006 and it becomes necessary to refer the emoluments drawn in pre revised pay structure prior to 01.01.2006 the corresponding pay would means and include Basic

Pay+ Dearness Pay+ Dearness allowance+ Fitment weightage @40% of Basic Pay in the Pre revised Pay scale of pay.

**Family pension**

Family pension shall regulate at a uniform rate of 30% of last pay drawn in prescribed pay band plus applicable grade pay in the revised Pay structure.

**Enhanced Family Pension:-**

Enhanced Family Pension shall regulate according to the formula given in the Haryana Aided-Schools(Special Pension & Contributory Provident Fund) Rules, 2001(amended) but it shall not be less than Rs.3500 per month.

**Minimum Pension/Family Pension:-**

Minimum Pension/Family Pension shall not be less than Rs. 3500/- in all cases irrespective of length of qualifying service or otherwise.

**(3) Pension on or after 01.08.2011 shall regulate as under:-  
Pension**

- (a) Pension of an employee retired or will retire on or after 01.08.2011 and have completed minimum qualifying service of 10 years shall be calculated taking the last pay drawn including entitled Grade Pay in the revised pay structure under 6<sup>th</sup> pay commission.
- (b) Benefit of full pension will be admissible on completion of 28 years of qualifying service. In case the qualifying service is less than it will be calculated proportionately in the manner specified below:-
  - (i) In cases of qualifying service being 28 years or above '56/112'.
  - (ii) In cases where the actual qualifying service falls short of 28 years but happens to be more than 10 years : 'Number of qualifying service in half yearly (HY)/112'.
- (c) Minimum Pension in no case be less than 3500/- per month.

**Family Pension on or after 01.08.2011:-**

Family Pension shall be 30% of last pay plus Grade Pay drawn in the revised pay structure but it will in no case be less than Rs. 3500/- per month.

**Enhanced Family Pension:-**

Enhanced Family Pension shall be equal to the 50% of last pay plus Grade Pay drawn in the revised pay structure but it will not be more than the pension entitled to the deceased in employee had he retired on superannuation.

**Death-cum-Retirement Gratuity**

The maximum ceiling of DCRG has been raised from Rs. 3.50 Lac to Rs. 10.00 Lac w.e.f. 01.08.2011, however, the calculation formula shall remain the same as per Haryana Aided-Schools(Special Pension & Contributory Provident Fund) Rules, 2001(amended) i.e. upto qualifying service of 33 years and 35 years in the case of Class-IV employees as the case may be.

**(4) DEFINITION OF FAMILY :-**

The definition of family pension shall be the same as issued by the Government to these employees as amended from time to time.

The eligibility conditions of the pension/family pension/DCRG in the existing Pension Rules namely Haryana Aided Schools (Special Pension & Contributory Provident Fund) Rules, 2001 (Amended) shall remain the same.

**(5) Arrears**

The arrear of pension/family pension and DCRG shall commence from 01.08.2011.

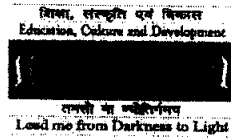

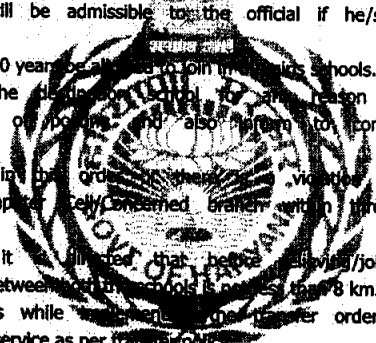
